In continuation to this office letter No. BD/S-4/2015-16/721-28 Dtd. 08-10-2015, the Executive Engineer, Boleng PWD Division, Boleng re-invites bids on behalf of Governor of Arunachal Pradesh for the construction of works on TURNKEY BASIS as detailed below, from registered contractors of appropriate class and category possessing requisite qualification for participation in this type of projects.

Interested bidders may obtain further information at the same address. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs 1000.00 (Rupees One Thousand) Only. The Executive Engineer, Boleng Division, PWD, AP, Boleng will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
3. Bids must be accompanied by security of the amount specified for the work in the table, payable at State Bank of India, Aalo Branch and drawn in favour of Executive Engineer, Boleng Division, PWD, AP, Boleng. Bid security will have to be in anyone of the forms as specified in the bidding document and shall have to be valid for **45 (Forty Five) days** beyond the validity of the bid.
4. Bids under two separate sealed covers for individual packages super scribed as “TECHNICAL BID’ and ‘FINANCIAL BID’ must be delivered to Executive Engineer, Boleng Division, PWD, AP, Boleng on or before **1200** hours on **10-02-2016** and will be opened on the same day at **1500** hours, in the presence of the bidders who wish to attend. If the office happens to be closed on

the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.

5. A pre-bid meeting will be held on **03-02-2016** at **1100** hours at the office of Superintending Engineer, Boleng Circle, PWD, Boleng, Arunachal Pradesh to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of 'Instructions to Bidders' of the bidding document.
6. The Employer reserves the right to accept or reject any bid, and to cancel the bidding process and reject all bids, at any time prior to the award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform affected bidder or bidders of the grounds for the employer's action.
7. The bidder who fulfills the following initial requirements shall only be eligible to participate
  - a) Experience of having successfully completed at least one similar work of aggregate cost not less than Rs 1000.00 Lakhs ( Rupees One Thousand) Lakhs only, during last 5(five) years ending last day of January'2015.
  - b) Has an annual financial turn over in civil engineering construction works in any one year during the last 5(five) years ending March'2015 of value not less than Rs 4600.00 Lakhs ( Rupees four Thousand six hundred) Lakhs only.
8. The bidder, at the bidder's own responsibility and risk is encouraged to visit the proposed site and obtain necessary information related to it to facilitate preparation of the bid.
9. In the event of more than one qualified bidder quoting the same amount, the award of work shall be determined by the Bid capacity of the bidders, inclusive of conditions of clause 4.8 of ITB.
10. The Bidder will have to submit NO DUES CERTIFICATE (NDC) /NO OBJECTION CERTIFICATE (NOC) from Arunachal Pradesh State Cooperative Apex bank Limited , duly issued by the Managing Director cum Chief Executive Officer , Itanagar along with the bid.
11. All the requisite information/documents are to be submitted in an orderly manner as and where required by indexing them as detailed in the relevant section(s) of the bidding document. The guarantees, certificates, etc from bank(s) and other authorities and other information shall be furnished as per the standard forms given in the relevant section(s) of the Bidding Document.
