- 3. Tender documents will be issued to eligible contractors between 1000 hrs to 1600 hrs from 10.02.2018 to 15.02.2018 on every working day except Sunday and Public Holidays from the office of the Executive Engineer, Anini Division, PWD Anini for a non refundable fee as indicated in the above table (Col-5) in the form of cash or demand draft on any scheduled bank payable at State Bank of India, Anini in favour of 'The Executive Engineer, Anini Division, PWD, A.P' provided they produce definite proof of registration / proof from the appropriate authority which shall be to the satisfaction of competent authority.

- 4. Tender must be accompanied by Earnest Money of the amount specified for the work in Column No:4 of the above table in the form of **Deposit at Call Receipt of a Schedule Bank/Fix Deposit of a Schedule Bank** issued in favour of 'The Executive Engineer, Anini Division, PWD, A.P'. The Earnest money has to be valid for 60 days beyond the validity of the Tender.
- 5. No Tender Paper shall be issued if the contractor fails to produce NDC/ NOC from the Arunachal Pradesh State Apex Bank limited, Naharlagun, issued by the Managing Director Cum Chief Executive Officer.
- 6. Once Tender paper issued in favour of particular Name/ Firm shall not be changed at any circumstances. The under signed reserves the right to accept /reject any or all the application without assigning any reason.
- 7. The Arunachal Pradesh District Based Entrepreneurs' and Professionals (Incentives, Development and Promotion) Act 2015 shall be mandatorily applied.
- 8. Others details can be seen in the bidding documents in the office of **The Executive Engineer**, **Anini Division**, **PWD**, **A.P** during working hour.
- 9. Agreement shall be drawn with the successful tenderer on prescribed Form No. PWD-7/8 of CPWD Works manual. Tenderer shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
- 10. Tenders, which should always be placed in sealed envelope marked as Tender document and Earnest Money will placed in another sealed envelope marked as Earnest Money and tagged with envelope of Tender Document with the name of work and due date written on the envelopes, will be received by the **Executive Engineer**, **Anini Division**, **PWD**, **A.P** up to 1500 Hrs. on 16.02.2018 and will be opened by him or his authorised representative in his office on the same day at 1530 Hrs.
- 11. The intending tenderers are advised to visit the site of work at his own cost and examine it and its surroundings to collect himself all information that he consider necessary for proper assessment of the prospective assignment.
- 12. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
- 13. The competent authority on behalf of Governor of AP reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
- 14. The contractor shall not be permitted to tender for works in the PWD Circle (responsible for award and execution of contracts) in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of superintending Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazetted officer in the Arunachal Public Works Department. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
- 15. No Engineer of gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of AP is allowed to work as a contractor for a period of one year after his retirement from Government service, without the previous permission of the Government of AP in writing. This contract is liable to be canalled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of AP as aforesaid before submission of the tender or engagement in the contractor's service.
- 16. The tender for the works shall remain open for acceptance for a period of 90 (Ninety) days from the date of opening of tenders. If any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the tender which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the tenderer shall not be allowed to participate in the re-tendering process of the work.
- 17. This Notice inviting Tender shall form a part of the contract document. The successful tenderer/contractor, on acceptance of his tender by the Accepting Authority, shall, within 15 days from the stipulated date of start of the work, sign the contract consisting of:
 - a) The notice inviting tender, all the documents including additional conditions, specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance there-of together with any correspondence leading there-to.

b) Standard PWD Form 7/8

- 18. The award of the tender to the successful bidder shall be made only after reciept of **Administrative Approval & Expenditure Sanction** from the Govt. of A.P. against the scheme in ADA(2017-18).
- 19. The tender shall stand cancelled in case of non accord of **Administrative Approval & Expenditure Sanction** within this financial year (2017-18).
