The enlistment of the contractors should be valid on the last date of submission/receipt of tender. In case the last date of receipt of tender is extended, the enlistment of contractor should be valid on the original last date of submission/receipt of tender.

- 1. The work is estimated to cost Rs. 2425.00 Lacs. This estimate, however, is given as a approximate figure.
- 2. Bidding documents (and additional copies) may be purchased from the office of the Executive Engineer, PWD, Tezu from 16/09/015 to 19/09/2015 for a non refundable fee as indicated, in the form of Cash or Demand Draft on any scheduled bank payable at State Bank of India, Tezu in favour of the Executive Engineer, Tezu P.W Division. Interested bidder (s) may obtain further information at the same address. Bidding document requested by mail will be dispatched by registered/speed post on payment of an extra amount Rs 2500.00. The department will not be held responsible for postal delays, if any, in the delivery of the documents or non-receipt of the same.
- 3. Bids must be accompanied by Bid Security/Earnest Money of the amount specified for the work in the table above, payable at State Bank of India, Tezu drawn in favour of Executive Engineer, Tezu P.W Division. Bid Security/Earnest Money will have to be in any one of the forms as specified in the Bidding Document and shall have to be valid for 45 days beyond the validity of the bid. However, BG may not be adopted as an instrument as far as possible. Any bid security of duration shorter than what is required, or not in order in any manner, may be rejected instantly. In other words, bids not accompanied by a Bid Security/Earnest Money as prescribed shall be rejected at the time of opening of bids as non-responsiveness and shall not be forwarded to higher authority for further consideration.
- 4. The Earnest money/bide security shall be relaxed to Rs. 24.25 Lacs i.e. to 1%, in case of APST contractors on production of ST certificate as proof (Ref. SPWD/W-182/2013 (Pt) dated 06/07/2015).
- 5. Bids under two separate sealed covers for individual packages superscribed as "Technical Bid" and "Financial Bid" must be delivered to the Executive Engineer, Tezu PW Division, on working days and latest by 1500 hrs. on or before 03/10/2015. The "Technical Bid" will be opened on the same day at 1530 hrs. by the Executive Engineer, Tezu PW Division or an authorized representative of the Executive Engineer, Tezu PW Division, in the presence of the bidder(s) or authorized representative(s) of the bidder(s) who wish to attend. If the office happens to be closed on the last date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. "Technical Bids" shall be evaluated by a screening/evaluation committee at the Division/Circle/Zonal office whose decision shall be final as the case may be, and the bidder(s) who qualify shall be invited to attend the opening of "Financial Bids" for which the date and venue will be intimated later on.

- 6. The design will be arranged by the department and the details structural drawings will be furnished to the bidders by the department. It will be the responsibility of the bidders to work out the details Bill Of Quantity (BOQ) based on the detailed structural drawings supplied and bid will be made by the bidders based on this BOQ indicating the rate for each item conforming to the specification given under Section 5 (Technical Specification). Bid submitted with out detailed bill/schedule of quantity indicating rates of each items shall be rejected.
- 7. The Employer reserves the right to accept or reject any bid, and to cancel the bidding process and reject all bids, at any time prior to the award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform affected bidder or bidders of the grounds for the employer's action.
- 8. The contractor shall not be permitted to tender of works, PWD Circle responsible for award and execution of the contract in which his near relative is posted as Divisional Accountant or as and officer in any capacity between the grades of Superintending Engineer and Asstt. Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity are subsequently employed by him and who are near relatives to any gazetted officers in the Public Works Department.
- 9. The tender for the work shall remain open for acceptance for a period of 90 (ninety) days from the opening of tenders/bids. If any tenderer withdraws his tender before the said period or issuing of letter of acceptance, which ever is earlier or makes any modification in the terms and condition of tender which are not acceptable to the Department, then the Government shall, without prejudice any other rights or remedy, be at liberty to cause the tenderer/bidder to forfeit 50% of the earnest money and the tenderer/bidder shall not be allowed to participate in the re-tendering process of the work.
- 10. No joint venture shall be entertained
- 11. A pre-bid meeting will be held on <u>21-09-2015</u> at 1130 hours in the office of the <u>Superintending Engineer</u>, <u>Tezu PW Circle</u>, <u>AP</u>, <u>Tezu to clarify issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of "Instructions to Bidders" of the bidding document.</u>
- 12. The bidder who fulfills the following initial requirements shall only be eligible to participate.
 - a) Experience of having successfully completed one building project/building projects of aggregate cost not less than Rs. 1212.50 Lakhs during the last 5 years ending last day of August'2015. Preference will be given to the bidders who has/have completed a similar work/works.
 - b) Has an annual financial turn over in civil engineering construction works in any one year during the last five (5) years ending March, 2015 of value not less than **Rs. 2425.00 Lakhs.**
- 13. The bidder will have to produce No Dues Certificate (NDC)/No Objection Certificate (NOC) from the Arunachal Pradesh State Co-operative Apex Bank Limited, duly issued by the Managing Director cum Chief Executive Officer, Itanagar along with the bid in order to participate. The NDC/NOC whose validity has expired will not be accepted.
- 14. The tenderer/bidder shall submit Income Tax clearance certificate or Income Tax Exemption certificate as the case may be.
- 15. Other details and other documents to be submitted will be as described in the bidding document.
- 16. The bidder, at the bidder's own responsibility and risk is encouraged to visit the project site and obtain necessary information related to it to facilitate preparation of the bid.
- 17. In the event of more than one qualified bidder quoting the same amount, the award of work shall be determined by the Bid Capacity of the bidders, inclusive of conditions of clause 4.8 of ITB.
- 18. a) Any contractor who has two (02) or more uncompleted ongoing commitments (projects to execute/contracts at hand) is not permitted to participate in this bidding. A bidder will invariably submit an affidavit sworn before a competent magistrate to the effect that he does not have two (02) or more uncompleted ongoing commitments at the time of bidding. The affidavit should mention the names of the uncompleted ongoing commitments. Any bid which does not fulfill this condition will summarily be rejected. In the event of submission of false information, which may be detected by the department after award of works, the tender shall be cancelled immediately & the contractor shall be barred from further participation in any tender(s) of the Department.
