The Chief Engineer, PWD, Eastern Zone re- invites bids/tenders on behalf of the Governor of Arunachal Pradesh for execution of works on Turnkey basis from registered contractors of appropriate class as detailed below. The interested bidder is advised to examine carefully all instructions including addenda /amendments to ITB, Conditions of Contract, Contract Data, Technical Specifications, Bill of Quantities, various forms, Terms and Conditions, etc in the Bid/Tender Document.

- Bidding documents (and additional copies) may be purchased from the office of the Executive Engineer, PWD, Khonsa from 25/09/2014 to 04/10/2014 for a non refundable fee as indicated, in the form of Cash or Demand Draft on any scheduled bank payable at **State Bank of India, Khonsa** in favour of the **Executive Engineer, Khonsa P.W Division**. Interested bidder (s) may obtain further information at the same address. Bidding document requested by mail will be despatched by registered/speed post on payment of an extra amount of Rs. 2500.00. The department will not be held responsible for postal delays, if any, in the delivery of the documents or non-receipt of the same.
- Bids must be accompanied by a bid security of the amount specified for the work in the table show above, payable at **State Bank of India, Khonsa** drawn in favour of **Executive Engineer, Khonsa P.W Division**. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid. However, BG may not be adopted as an instrument as far as possible. Any bid security of duration shorter than what is required, or not in order in any manner, may be rejected instantly. In other words, bids not accompanied by a bid security as prescribed shall be rejected at the time of opening of bids and shall not be forwarded to higher authority for further consideration.
- Bids under two separate sealed covers for individual packages superscribed as "**Technical Bid**" and "**Financial Bid**" must be delivered to the **Executive Engineer, Khonsa PW Division**, on working days and latest by 1500 hrs. on or before 07/10/2014. The "**Technical Bid**" will be opened on the same day at 1530 hrs. by the **Executive Engineer, Khonsa PW Division** or an authorized representative of the **Executive Engineer, Khonsa PW Division**, in the presence of the bidder(s) or authorized representative(s) of the bidder(s) who wish to attend. If the office happens to be closed on the last date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. "**Technical Bids**" shall be evaluated by a screening/evaluation committee at the Division/Circle/Zonal office whose decision shall be final as the case may be, and the bidder(s) who qualify shall be invited to attend the opening of "**Financial Bids**" for which the date and venue will be intimated later on.



4. The Employer reserves the right to accept or reject any bid, and to cancel the bidding process and reject all bids, at any time prior to the award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform affected bidder or bidders of the grounds for the employer's action.
5. As regard unreinforced dowel jointed plain CC pavement and dry lean cement concrete, design and development of drawings shall be done by the contractor as per IRC:58:2002 (Second Revision), and other relevant IRC codes. Soil and other tests may be conducted by the contractor as prescribed in these codes, wherever felt necessary, before design and development of the drawings. The design note and drawings shall be submitted by the contractor to the department within one (1) month of award of the work. The design note and drawings thus submitted shall be counter - checked or got proof -checked in an institute of repute by the department before formal issue and adoption for execution. Conduct of soil and other tests, design and development of the drawings shall be an integral part of the overall work and nothing extra shall be paid to the contractor on account of this. In the event that the design and drawings are proof-checked by an institute of repute, the fee for proof -checking shall also be borne by the contractor from out of the overall contract amount and nothing extra shall be paid to him on this count.
6. A pre-bid meeting will be held on 29/09/2014 at 1130 hours in the office of the Superintending Engineer, Jairampur PW Circle, AP/ Executive Engineer, Khonsa PW Division, AP, to clarify issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of "**Instructions to Bidders**" of the bidding document.
7. The bidder who fulfills the following initial requirements shall only be eligible to participate.
  - a) Experience of having successfully completed atleast one road pavement work of aggregate cost not less than **Rs. 449.00 Lakhs** during the last 5 years ending last day of August' 2014. Preference will be given to those bidders who have completed **similar work(s)**.
  - b) Has an annual financial turn over in civil engineering construction works in any one year during the last five (5) years ending March' 2014 of value not less than **Rs. 2245.00 Lakhs**.
8. The bidder will have to submit a No Dues Certificate (NDC)/No Objection Certificate (NOC) from the Arunachal Pradesh State Co-operative Apex Bank Limited, duly issued by the Managing Director cum Chief Executive Officer, Itanagar along with the bid.
9. Other details and other documents to be submitted will be as described in the bidding document.
10. The bidder, at the bidder's own responsibility and risk is encouraged to visit the project site and obtain necessary information related to it to facilitate preparation of the bid.
11. In the event of more than one qualified bidder quoting the same amount, the award of work shall be determined by the Bid capacity of the bidders, inclusive of conditions of clause 4.8 of ITB.
12. Any contractor who has two (02) or more uncompleted ongoing commitments (projects to execute/ contracts at hand) is not permitted to participate in this bidding. A bidder will invariably submit an affidavit sworn before a competent Magistrate to the effect that he does not have two (02) or more uncompleted ongoing commitments at the time of bidding. The affidavit should mention the names of the uncompleted ongoing commitments. Any bid which does not fulfill this condition will summarily be rejected. In the event of submission of false information, which may be detected by the department after award of works, the tender shall be cancelled immediately & the contractor shall be barred from further participation in any tender works of the Department.
13. The information/documents mentioned in (7), (8), and (9) above should be submitted in an orderly manner as and where required by indexing them as detailed in the relevant section(s) of the Bidding Document. **The guarantees, certificates, etc from bank(s) and other authorities and other information shall be furnished strictly repeat strictly as per the standard forms given in the relevant section (s) of the Bidding Document. They must not be older than three (3) months and must be signed by the competent authority himself /herself with proper official seal. Non-compliance on these counts may lead to rejection of bid on account of non-responsiveness.**

14. The bidder who was LI in the first round of bidding shall not be allowed to participate in this re-tendering .
