## NOTICE INVITING e-TENDERING

Item rate bids are invited on behalf of the Governor of Arunachal Pradesh on line from all registered eligible contractors. The eligibility of the tenderer shall be guided by the District Based Entrepreneurs and Professional (Incentives, Development and Promotional) Act 2015 for the work of **“Construction of Road from Jongjihavi to Sangkhuhavi (SH:Widening,Slab Culvert,R/wall,B/wall,DBM & DC) at Changlang District Ph-II.**

The enlistment of the contractors should be valid on the last date of submission of bids. In case the last of submission of bids is extended, the enlistment of contractor should be valid on the original date of submission of bids.

1.1.0 The work is estimated to cost **Rs. 990.00 Lakhs** (Nine crore seventy one lakhs)only. This estimate, however, is given merely as a rough guide.

1.2 .1 The eligibility of the bidders shall be guided by the provision of memo no. SPWD/W-66/2012/314, dated 13/08/2015.

1.2.2 Intending bidders is eligible to submit the bid provided he has definite proof from for the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below:-

1.2.3 Criteria of eligibility for submission of bid documents.

Three similar works each of value not less than **Rs. 330.00 lakhs** for Non-APST and **Rs.260.00 lakhs** for APST contractors or two similar work each of value not less than **Rs. 500.00 lakhs** for Non-APST and **Rs 400.00 lakhs** for APST contractors or one similar work of value not less than **Rs.1000.00 lakhs** for Non-APST and **Rs. 830.00 lakhs** for APST contractors(all figures rounded to nearest Rs.10 lac) in last 5 years ending previous day of last date of submission of bids. The value of executed works shall be brought to the current costing by enhancing the actual valu of work at simple rate of 7% per annum, calculated from the date of completion to the last date of submission of bid.

**To become eligible for issue of bid, the bidders shall have to furnish an affidavit as under:-**

I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred forbidding in PWD in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee. (Scanned copy to be uploaded at the time of submission of bid).

1.2.4 But for such bids, contractors of PWD are eligible to submit the bids without submission of work experience certificate and affidavit. Therefore, PWD contractors will upload two separate letters for experience certificate and affidavit that these documents are not



required to be submitted by them. Uploading of these two letters is mandatory otherwise system will not clear mandatory fields.

2. Agreement shall be drawn with the successful bidders on prescribed Form No. PWD-8 (or other Standard Form as mentioned) which is available as a Govt. of India/ Govt. of Arunachal Pradesh publication and also available on website [www.arunachaltenders.gov.in](http://www.arunachaltenders.gov.in). Bidders shall quote his rates as per various terms and conditions of the said form which will part of agreement.

The time allowed for carrying out the work will be 24 months from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the bid documents.

4. The site for the work is available.

The architectural/detailed design and structural drawings shall be made available in phased manner, as per requirement of the same as per approved programmed of completion submitted by the contractor after award of work. The work shall be executed by the contractor strictly as per approved design/structural drawings and specifications.

5. The bid document consisting of schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents except Standard General Conditions of Contract Form can be seen on website [www.arunachaltenders.gov.in](http://www.arunachaltenders.gov.in). free of cost.

6. After submission of the bid the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.

7. While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.

8. Earnest Money for **Rs. 19,80,000.00** for Non-APST contractors and **Rs. 9,90,000.00** for APST contractors, in the form of Treasury Challan/Demand draft/Pay order/Banker's cheque/Deposit at call receipt/ Fixed deposit receipt (drawn in favour of Executive Engineer, Changlang Division, PWD, AP, Changlang) shall be scanned and uploaded to the e-Tendering website within the period of bid submission.

The original EMD should be deposited in the office of the Executive Engineer, Changlang Division, PWD, AP, Changlang within the period of bid submission. (The EMD Documents shall only be issued from the place in which the office of receiving Division Office is situated. The EMD receiving Executive Engineer shall issue a receipt of deposition of earnest money deposited by the bidder in a prescribed format (Enclosed) uploaded by tender inviting EE in the NIT.

This receipt shall also be uploaded to the e-tendering web site by the intending bidders up to the specified bid submission date and time.

Copy of Enlistment Order and certificate of work experience and other documents as specified in the press notice shall be scanned and uploaded to the e-tendering website within the period of bid submission. However, certified copy of all the scanned and uploaded documents as specified in press notice shall have to be submitted by the lowest bidder only within a week physically in the office of tender opening authority.

Online bid documents submitted by intending bidders shall be opened only of those bidders, who original EMD deposited with the division and other documents scanned and uploaded are found in order.

The bid submitted shall be opened/downloaded at 1100 hrs. on 22/08/2019 in the office of the Executive Engineer Changlang Division, PWD, AP, Changlang.

9. The bid submitted shall become invalid if
- i. The bidder is found ineligible.
  - ii. The bidder does not upload original EMD with the division Office Of the Executive Engineer, Changlang Division, PWD, AP, Changlang (The EMD documents shall only be issued from the place in which the office of receiving division office is situated).
  - iii. **It is mandatory to upload scanned copies of all the documents including GST registration.** If these documents are not uploaded, then bid will become invalid and shall summarily be rejected.
  - iv. **The bid submitted shall become invalid if:** The bidder does not upload all documents (including GST registration) as stipulated in the bid document including the copy of receipt for deposition of original EMD instrument.

10. The contractor whose bid is accepted will be required to furnish performance guarantee of 5%(Five Percent) of the bid amount within the period specified in Schedule-F. This guarantee shall be in the form of cash (in case guarantee amount is less than Rs. 10000/-) or Deposit at Call receipt of any scheduled bank/Banker's cheque of any scheduled bank/Demand Draft of any scheduled bank/Pay order of any Scheduled bank and bank guarantee of any Scheduled bank (in case guarantee amount is less than Rs. 1,00,000/-) or Government Securities or Fixed Deposit Receipts or Guarantee Bonds of any Scheduled Bank or the State Bank of India in accordance with the prescribed form. In case the contractor fails to deposit the said performance guarantee within the period as indicated in Schedule 'F', including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor. The earnest money deposited along with bid shall be returned after receiving the aforesaid performance guarantee.

11. The description of the work is as follows:

Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the



accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidders shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidders shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by bidders implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and local conditions and other factors having a bearing on the execution of the work.

12. The competent authority on behalf of the Governor of Arunachal Pradesh does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.

13. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection.

14. The competent authority on behalf of Governor of Arunachal Pradesh reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.

15. The contractor shall not be permitted to bid for works in the PWD Circle responsible for award and execution of contracts, in which his near relative is posted a Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer to Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any Gazetted officer in the Public Works Department. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.

16. No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of Arunachal Pradesh is allowed to work as a contractor for a period of one year after his retirement from Government service, without the prior permission of the Government of Arunachal Pradesh in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of Arunachal Pradesh as aforesaid before submission of the bid or engagement in the contractor's service.

17. The bid for the works shall remain open for acceptance for a period of sixty (60) days from the date of opening of bids. If any bidders withdraws his bid before the afore said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said

earnest money as aforesaid. Further the bidders shall not be allowed to participate in the rebidding process of the work.

18. This notice inviting Bid shall form a part of the contract document. The successful bidders/contractor, on acceptance of his bid by the Accepting Authority shall within 15 days from the stipulated date of start of the work, sign the contract consisting of:-

The Notice Inviting Bid, all the documents including additional conditions, specification and drawing, if any, forming part of the bid as uploaded at the time of invitation of bid and the rates quoted online at the time of submission of bid and acceptance thereof together with any correspondence leading thereto. Standard PWD Form 7/8 or other standard PWD Form as applicable.

19. The work shall be formally awarded on receipt of Administrative approval and Expenditure sanction from the Government of Arunachal Pradesh.
