The Executive Engineer, Capital Division-A, PWD, Arunachal Pradesh, Itanagar on behalf of the Governor of Arunachal Pradesh invites online item rate e-tender in single bid system from all registered contractors in class-II as per Arunachal Pradesh District based entrepreneurs and professionals incentives (Development & promotional) Act 2015 published vide Notification No. SPWD/W-66/2012 dated 13th August 2015 and published in Arunachal Pradesh Extra Ordinary Gazette vide No.224 Vol-XXII dated 11th September 2015 and amendment of Arunachal Pradesh enlistment of Contractors in work department Rule-2008 vide order No. SPWD/W-336/Contract/2006-07/1079 dated 01.10.2018 & of equivalent class of contractor with similar bidding capacity but enlisted out side of the state of the Arunachal Pradesh and conforming to territorial jurisdiction of Assembly Constituency for following work(s).



CPWD-6, Proforma of Schedules A to F, Special conditions/Specifications only will be uploaded to tendering website. The GCC-2020 (standard form) will also be uploaded along with the Tender documents and the same shall form part of the agreement to be drawn and signed by both parties after acceptance of tender.

Criteria of eligibility for APPWD as well as Non-APPWD contractors.

1. In the larger interest of the public and for equitable distribution of development works amongst eligible contractors and also to ensure effective management and quality of works, a contractor shall be allowed to have only 3 (three) works in hand in any of departments under Government of Arunachal Pradesh at a time and for which he shall make a declaration to be executed in an Affidavit that he is not engaged in more than two tenders works under the State Government of Arunachal Pradesh.
2. 3 (three) similar works each of value not less than ₹ 197.20 Lakhs (40% of estimated cost) or 2 (two) similar works each value not less than ₹ 295.80 Lakhs (60% of estimated cost) or 1(one) work of value not less than ₹ 394.40 Lakhs (80% of estimated cost) [all figures rounded to nearest convenient figure], in the last 5 (five) years ending last day of the month previous to the one in which the tenders are invited.
The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of receipt of applications for tender.
3. The original EMD should be deposited in the office of the Assistant Engineer Capital Sub-Division No.6/A, PWD, AP, Itanagar within the period of bid submission including Cost of Tender Paper ₹ 1000/- (Rupees One thousand)only in Cash and the receipt of the Same is Uploaded.
4. Contractor must have experience in the construction of MSE (Gabion cum Green Terramesh) work or must have M.O.U with reputed company with required credential like M/S Maccaferri Environmental Solutions Pvt. Limited,duly executed before the 1st Class magistrate or else contractor shall be rejected straight away considering as inexperience in special item of MSE works.

For the purpose of this clause 'similar work' means the works of "Construction of MSE (Gabion & Terramesh Wall), Bituminous Road, & Embankment work" in hilly/Plain terrain".
