2. Information and Instructions for bidders posted on website shall form part of bid document.
3. The bid document consisting of specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website [www.arunachaltenders.gov.in](http://www.arunachaltenders.gov.in) free of cost.

4. But the bid can only be submitted after deposition of original EMD in the office the Executive Engineer inviting bid within the period of bid submission. (The EMD Documents shall only be issued from the place in which the office of the receiving division office is situated) and uploading the mandatory scanned documents such as Demand Draft or Pay order or Banker's Cheque or Deposit at call Receipt or Fixed Deposit Receipts and Bank guarantee of any Scheduled Bank towards EMD in favour of Executive Engineer, Khonsa Division, PWD, AP, Khonsa as mentioned in NIT, receipt for depositing of original EMD to division office of the Executive Engineer and other documents as specified.
5. Those contractors not registered on the website mentioned above, are required to get registered before and. If needed they can be imparted training on online bidding process as per details available on website.
6. The intending bidder must have valid class-III digital signature certificate to submit the bid.
7. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
8. Contractor can upload documents in the form of **JPG** format and **PDF** format.

9. Contractor must ensure to quote rate of each item only.
10. The technical bid shall be opened first on due date and time mentioned above. The time and date of opening of financial bid of contractors qualifying the technical bid shall be communicated later on.

In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).


