NOTICE INVITING TENDER

The Executive Engineer, Ziro Division, PWD, AP, Ziro on behalf of the Governor of Arunachal Pradesh, invites Sealed Item Rate Tender from eligible and registered contractors under union of India on appropriate class and shall be governed by Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and promotional) (Amendment) Act No. 7 of 2020).

1. Eligibility Criteria :

- (i) The eligibility of contractors/bidders shall be governed by the provisions of Memo No. SPWD/W-66/2012/314, dated 13-08-2015
 - (ii) The participants must have successfully executed in Central/State Govt./PSU's three similar works each of value of 40% of the estimated cost or two similar works each of value 60% of the estimated cost or one similar work of value 80% of the estimated cost during last five years.
 - (iii) Since the SASCI project is valid for current financial year only and the project has to be completed by 31st March 2024 by any means. Therefore following special condition are put in the tender.
 - A. Preferences will be given to the firm having T&P setup within the vicinity of 5.00 to 10.00 Km from the work site as mentioned in the Schedule A to F Clause 18.
 - B. Preference will be given to the firm having experience in construction of Cement Treated Sub Base /Base construction.
2. Tender papers will be issued to eligible contractors on production of definite proof from the appropriate authority.
 3. Tender paper can be purchased from the office of the **Executive Engineer, Ziro Division, PWD, Ziro** on all working days by submitting Application and on payment of cost of Tender Paper in cash (non-refundable) from **04-12-2023 to 05-12-2023 (up to 1600 hrs)**. Tender Document requested by mail/post will be dispatched by registered/speed post on payment of an extra amount of **Rs. 2000.00**. The department will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
 4. Tender must be delivered to the **Executive Engineer, Ziro Division, PWD, Ziro** on or before **1130 hrs on 08-12-2023** The Tender will be opened on the same at **1500 hrs** in the office of the **Executive Engineer, Ziro Division, PWD, Ziro** by him or his authorized representative in the presence of intending tenderers.
 5. The Earnest Money of the amount specified above in the form of ~~Demand-Draft~~/Banker ~~Cheque~~/Fixed Deposit Receipt/Term Deposit Receipt in favour of the Executive Engineer, PWD AP, Ziro should be enclosed with the Tender document in separate sealed cover.

6. The intending Firms/Contractors should furnish the No-Due Certificate (NDC)/ No Objection Certificate (NOC) from Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issued on or after **12-06-2023** by the Managing Director Cum Chief Executive Officer. No Tender Paper shall be issued to any intending bidder without submission of NDC from Arunachal Pradesh State Co-Operative Apex Bank Limited.
7. The intending Firms/Contractor should submit Income Tax clearance Certificate for the last one year or Income Tax exemption certificate as the case maybe.
8. Other document/information required to be furnished by the tenderers are described in the Tender documents.
9. Bidders are advised to inspect the site and its surroundings and satisfy themselves before submitting their tenders.
10. The competent authority reserved the right to reject any or all the Tender without assigning any reason
11. The Tender without earnest money in proper form shall be summarily rejected.
12. The payment shall be made as per allocation of fund according to year wise phasing. The Department shall not be held responsible for delay in payment in case of non-release of fund by the Govt. as per phasing.
13. The APST contractors shall submit ST Certificate to avail relaxation of Earnest Money in favour of them. Original ST Certificate should be produced at the time of opening of the Tender. No relaxation shall be admissible without submission of ST Certificate.


