4. The work is estimated to cost **Rs 25.08 lakh** approximately or as subsequently amended in tender documents through corrigendum on CPPP website <https://eprocure.gov.in/eprocure/app> (link-Tender by Organisation – link - Border Road Organisation). This estimate, however, is not a guarantee and is merely given as a rough guide and if works cost more or less, the tenderer shall have no claim on that account of what so ever nature.

5. The tender shall be based on General Conditions of Contract **IAFW-1815 (Z) and Contract form based on IAFW-1815 (R)** with special conditions, particular specifications and schedule 'A' (list of works) to be priced by tenderers.

6. Not more than one tender shall be submitted by one contactor or contractors having business relationship. Under no circumstance will father and his son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.
7. The work is to be completed within **90 days (Ninety days)** or as subsequently amended in tender documents or uploaded on CPPP site <https://eprocure.gov.in/eprocure/app> (link- Tender by Organisation – link - Border Road Organisation) in accordance with the phasing, if any, indicated in the tender from the date of handing over the site, which will be generally within one month from the date of issue of acceptance letter.
8. **The Chief Engineer, Project Arunank, will be the Accepting Officer** hereinafter referred to as such, for the purpose of this contract.
9. Earnest money is not required to be attached with tender by the enlisted contractor with BRO who have submitted standing security deposit but it is required from other contractors to be attached with tender documents for **Rs. 50,200.00 (Rupees Fifty Thousand Two Hundred Only)** payable at **SBI NAHARLAGUN (Code No. 03232)** in the form of Deposit at Call Receipt/ Term Deposit Receipt/ Special Term Deposit Receipt issued in favour of **Chief Engineer (P) Arunank, C/O 99 APO** obtained from any Nationalized/Scheduled Bank and having maturity/validity period 30 days more than validity period of his offer. Un enlisted contractor may note that they will be required to lodge security deposit of the work in the prescribed form on receipt in writing from the Accepting Officer if their offer is accepted.
10. Earnest Money Deposit of all unsuccessful tenderers will be returned immediately by endorsing an authority for its refund. The Earnest Money Deposit of the successful tenderer will be returned on receipt of the full security deposit or will be treated as a part of the security deposit.

The Accepting Officer reserves his right to accept a tender submitted by a Public Undertaking, giving a purchase preference over other tender(s) which may be lower, as are admissible under the Govt policy. No claim for any compensation or otherwise shall be admissible from such tenderers whose tenders may be rejected on account of the said policy.

The submission of a tender by a tenderer implies that he had-read this notice and conditions of contract and has made himself aware of the scope and specifications of the work to be done and of the conditions and rates at which stores, tools and plants etc will be issued to him, local conditions and other factors bearing on the execution of the work.

18. Same can be also given in person. Scanned copy of the instrument should be uploaded as part of the offer. Tenderer shall likely to be liable for legal action for non-submission of original payment instrument like TDR, etc., against the submitted bid. **Bids shall be strictly treated as non-responsive if Bid is not accompanied by :-**

- (i) **An acceptable EMD.**
- (ii) **The undertaking regarding acceptance of tender conditions.**
- (iii) **Registration certificate under GST ACT 2017, NEFT Form, EPFO Registration and PAN Card.**

19. The Accepting Officer does not bind himself to accept the lowest or any tender or to give any reasons for doing so.

20. The tender will be accepted **as a whole for lowest cost as per discretion of Accepting Officer.** The tender shall remain open for acceptance for a period of **90 days** from the stipulated date of opening of priced bid.

21. For eligibility criteria and other details, tender documents uploaded on websites shall be referred.

In case BRO enlisted contractors, the amount equal to the earnest money stipulated in the Notice of tender, shall be notified to the tenderer for depositing the amount through MRO, failing which the amount shall be recovered from payment due to such contractor or shall be adjusted from the Standing Security Deposit. In addition, such tenderer and his related firm shall not be issued the tender in second call or subsequent calls.
