- Bids must be accompanied by security of the amount specified for the work in the table, payable at **State Bank of India, Hayuliang** drawn in favour of **Executive Engineer, Hayuliang P.W Division**. Bid Security will have to be in any one of the forms as specified in the Bidding Document and shall have to be valid for 45 days beyond the validity of the bid.
- Bids under two separate sealed covers for individual packages superscribed as "**Technical Bid**" and "**Financial Bid**" must be delivered to the **Executive Engineer, Hayuliang PW Division**, on working days and latest by 1500 hrs on or before 25-02-2014. The "**Technical Bid**" will be opened on the same day at 1530 hrs by the **Executive Engineer, Hayuliang PW Division** or his authorized representative in the presence of bidder(s) or authorized representative of the bidder(s) who wish to attend.. If the office happens to be closed on the last date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. "**Technical Bids**" shall be evaluated by a screening / evaluation committee at the Division office / Circle office/Zonal office. The bidder(s) who qualify shall be invited to attend the opening of "**Financial Bids**" for which the date and venue will be intimated later on.
- Prospective bidders are hereby informed that Administrative Approval and Expenditure Sanction of the project is awaited from the competent authority. This IFB has been called to expedite the tender formalities in anticipation of receipt of sanction. However, in the event that all the tender formalities are completed before expenditure sanction is accorded by the competent authority, the award of work to the successful bidder shall be put on hold and will be done only after receipt of expenditure sanction from the competent authority. The Department shall have no responsibility to any liability /obligation of the prospective bidder on account of any delay in award of work for such reasons. This point should be carefully taken note of by the bidders.

The Employer reserves the right to accept or reject any bid, and to cancel the bidding process and reject all bids, at any time prior to the award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform affected bidder or bidders of the grounds for the employer's action.

A pre-bid meeting will be held on 19.02.2014 at 1130 hours in the office of the Superintending Engineer, Tezu PW Circle, AP/ Executive Engineer, Hayuliang PW Division, AP to clarify issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of "Instructions to Bidders" of the bidding document.
7. The bidder who fulfills the following initial requirements shall only be eligible to participate.
 - a) Experience of having successfully completed atleast one similar work of aggregate cost not less than ₹ 170.50 Lakhs during the last 5 years ending last day of January'2014.
 - b) Has an annual financial turn over in civil engineering construction works in any one year during the last five (5) years ending March, 2013 of value not less than ₹ 852.50 Lakhs.
8. The bidder will have to submit a No Dues Certificate (NDC)/No Objection Certificate (NOC) from the Arunachal Pradesh State Co-operative Apex Bank Limited, duly issued by the Managing Director cum Chief Executive Officer, Itanagar along with the bid.
9. Other details and other documents to be submitted will be as described in the bidding document.
10. The bidder, at the bidder's own responsibility and risk is encouraged to visit the project site and obtain necessary information related to it to facilitate preparation of the bid.
11. In the event of more than one qualified bidder quoting the same amount, the award of work shall be determined by the Bid capacity of the bidders, inclusive of conditions of clause 4.8 of ITB.
