#### Criteria of eligibility for bidders

- The bidder should have satisfactorily completed the works as mentioned below during the last 7 (seven) years ending previous day of last date of submission of tenders: -
  - (a) 3 (three) similar works each of value not less than Rs 39.24 Lakhs (40% of estimated cost put to tender-ECPT) or 2 (two) similar works each of value not less than Rs. 58.86 Lakhs (60% of ECPT) or 1 (one) similar work of value not less than Rs 78.48 Lakhs (80% of estimated cost) (rounded off to nearest Rs 10 thousand).
  - (b) One completed work of any nature (either part of (a) above or separate one costing not less than the amount equal to Rs 39.24 Lakhs (40% of ECPT) with any of Central/State Government Department/ Central Autonomous Body/ State Autonomous body/ Central Public sector Undertaking/ State Public sector Undertaking/ City Development Authority/ Municipal Corporation of City.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of submission of bid. For the purpose of this clause 'similar work' means the works of "BUILDING WORKS with E&M works". Completion certificate with the correspondence address/e-mail id /contact no of issuing authority (in the rank of EE or above) must be uploaded while participating in the tender)

- The bidder should have had average annual financial turn-over (gross) of not less than Rs.49.05 Lakhs ( 50% of ECPT) on civil construction works during the last available Seven years balance sheets duly audited by Chartered Accountant.
- The bidder should not have incurred any loss in more than two years during the last five years as per balance sheets duly audited by Chartered Accountant.
- The bidding capacity of bidder shall be equal to or more than the ECPT of Rs 98.10 (Rupees Ninety Eight Lakhs Ten Thousand).
- The bidder shall submit a minimum solvency of Rs 39.24 lakhs certified by his Bankers. [ 40% of ECPT]
- The bidder shall submit existing Credit facility from Bankers for Rs 29.43 Lakhs. Including BG limit [30% of ECPT]
- 7. The bidder shall submit an affidavit to invest cash up to Rs 24.52 Lakhs (25% of ECPT).
- 8. Sub soil investigation shall be carried out by Bidders from reputed & accredited institutes/firms/lab with prior consent and approval of the Employer/Engineer-in-charge of the project. Architectural designs & drawings shall be obtained by Bidders from reputed Architects or Architectural Firms. Preliminary Architectural Drawing (optional) may be obtained from the office of undersigned on payment Rs 2000/- (Two thousand) per set in form of bank draft drawn in my favour on any schedule bank at Seppa. Structural design and drawings shall be prepared by reputed Structural Engineer or reputed Consultancy Firm. The proof-checks of the same shall be obtained from Superintending Engineer. Sagalee Circle, PWD, Bobia) only. The works shall be executed by the contractor strictly in accordance to approved designs & drawings and specification. The decision regarding admissibility of drawing, design for & during execution of the project vested with Employer Superintending, Engineer, Sagalee Circle, PWD, Bobia) or his authorized representative and shall remain binding to the contractor.
