NOTICE INVITING TENDER

Item Rate tenders are invited on behalf of the Governor of Arunachal Pradesh from approved and registered contractors in Class – I categories domiciled with in the Territorial jurisdiction of the District as per extra ordinary gazette notification published on April'2013 gazette No. 94 Vol. XXII for the work of

“C/O Road from NH229 Lumdung village to Rote Rome & Mebia Selle and Naraba via Lisa village, PH:-I, (6.00KM)”.

1.1 The work is estimated to cost as above. This estimate, however, is given merely as a rough guide. Quantity of work may vary during actual execution of work.

1.2 Tenders will be issued to registered Class – I contractors domiciled with in the jurisdiction of the District provided they produce definite proof from the appropriate authority regarding past experience and satisfactory completion of the works which must be to the satisfaction of authority competent to issue tender papers for the work.

Criteria of eligibility for issue of tender documents.
Condition for Non-PWD contractors

1. For works estimated to cost:- 3(three) similar works each of value not less than 40% of estimated cost or 2(two) similar works each value not less than 60% estimated cost or 1 (one) similar work of value not less than 80% estimated cost (rounded of nearest Rs. 10.00 Lakh), in the last 7 (seven) years including last day of month previous to the one in which the tenders are invited.

1.3 Keeping the problems in extracting forest products, minor mining and minerals in mind, the eligible local contractors shall be given preference

2. Agreement shall be drawn with the successful tenderer on prescribed Form No. PWD 8 which is available as a Govt. of Arunachal Pradesh Publication. Tenderer shall quote his rates as per various items and conditions of the said form which will form part of the Agreement.

3. The time allowed for carrying out the work will be **1 (One) Year** from the day after the date of written orders to commence the work or from the first date of handing over of the site, whichever is later.

4. The site for the work is available.

5. Receipt of applications for issue of forms will be stopped by 1600 Hrs. four days before the date fixed for opening of tenders. Issue of tender forms will be stopped three days before the date fixed for opening of tenders.

Tender documents consisting of plans, specifications, the schedule of quantities of the various classes of work to be done and the set of terms and conditions of contract to be complied with by the contractor whose tender may be accepted and other necessary documents can be seen in the office of the Executive Engineer PWD, Seppa Division, Seppa between 11.00 AM and 04.00 Pm every day except on Sundays and Public Holidays. Tender documents, excluding standard form, will be issued from his office, during the hours specified above, on payment of **10000/-** in cash (non-refundable).

6. Tenders, which should always be placed in sealed envelope, with the name of work and due date written on the envelopes, will be received by the undersigned upto 1500 hours on 14/12/2015. And will be opened by him or his authorized representative in his office on the same day at **03.30 PM**.
7. The tender shall be accompanied by earnest money, of **Rs. 7,15,400.00 (for General) Rs. 3,57,700.00 (for APST)** Deposit at Call receipt of a Schedule Bank issued in favour of **Executive Engineer, Seppa PW Division, Seppa** valid for not less than **60 days from the date of opening of tender**,
8. The description of the work is as follows:-

"C/O Road from NH229 Lumdung village to Rote Rome & Mebia Selle and Naraba via Lisa village, PH:-I, (6.00KM) (SH:- Jungle clearance, Formation cutting, RCC Slab Culvert, Protection Wall and Kutcha Drain etc."

Copies of other drawings and documents pertaining to the works will be open for inspection by the tenderers at the office of the above mentioned officer.

Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or effect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials tools and plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

9. The competent authority on behalf of Governor of Arunachal Pradesh does not bind to accept the lowest or any other tender and reserves to himself the authority to reject any or all of the tenders received without the assignment of a reason. All tenders in which any of the prescribed conditions are not fulfilled or are incomplete in any respect are liable to be rejected.

10. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
11. The competent authority on behalf of Governor of Arunachal Pradesh reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
12. The contractor shall not be permitted to tender for works in the PWD Circle (responsible for award and execution of contracts) in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Assistant Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazetted officer in the Public works Department. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
13. No Engineer of gazetted rank or other Gazetted officer employed in Engineering of Administrative duties in an Engineering Department of the Government of Arunachal Pradesh is allowed to work as a contractor for a period of two years after his retirement from Government service, without the previous permission of the Government of Arunachal Pradesh in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of Arunachal Pradesh as aforesaid before submission of the tender or engagement in the contractors service.
14. The tender for the works shall remain open for acceptance for a period of 15 days from the date of opening of tenders. If any tenderer withdraws his tender before the said period or makes any modifications in the terms and conditions of the tender which are not acceptable to the Department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% for the said earnest money as aforesaid.
15. This notice inviting tender shall form a part of the contract documents. The successful tenderer/contractor, on acceptance of his tender by the Accepting Authority, shall, within 15 days from the stipulated date of start of the work sign the contract consisting of:-
- a) The notice inviting tender, all the documents including additional conditions specifications and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.
- b) Standard PWD Form 8.
16. The value of executed works shall be brought to current casting level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of receipt application of tender.

For the purpose of this clause 'similar work' means the work of "any kind of civil construction work involving, cement concrete items, road and bridge construction work.
