
The Chief Engineer, PWD, Eastern Zone re-invites bids/ tenders on behalf of the Governor of Arunachal Pradesh for execution of works on Turnkey basis from registered contractors of appropriate class as detailed below. The interested bidders are advised to examine carefully all instructions including addenda /amendments to ITB, Conditions of Contract, Contract Data, Technical Specifications, Bill of Quantities, various forms, Terms and Conditions, etc in the Bid/Tender Document.

- Bidding documents (and additional copies) may be purchased from the office of the Executive Engineer, PWD, Roing from 28/11/2014 to 06/12/2014 for a non refundable fee as indicated, in the form of Cash or Demand Draft on any scheduled bank payable at State Bank of India, Roing in favour of the Executive Engineer, Roing P.W Division. Interested bidder (s) may obtain further information at the same address. Bidding document requested by mail will be dispatched by registered/speed post on payment of an extra amount Rs 2500.00. The department will not be held responsible for postal delays, if any, in the delivery of the documents or non-receipt of the same.
- Bids must be accompanied by a Bid Security/Earnest Money of the amount specified for the work in the table, payable at State Bank of India, Roing drawn in favour of Executive Engineer, Roing P.W Division. Bid Security/Earnest Money will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid. However, BG may not be adopted as an instrument as far as possible. Any bid security of duration shorter than what is required, or not in order in any manner, may be rejected instantly. In other words, bids not accompanied by a Bid Security/Earnest Money as prescribed shall be rejected at the time of opening of bids as non-responsiveness and shall not be forwarded to higher authority for further consideration.
- Bids under two separate sealed covers for individual packages superscribed as "Technical Bid" and "Financial Bid" must be delivered to the Executive Engineer, Roing PW Division, on working days and latest by 1500 hrs. on or before 09/12/2014. The "Technical Bids" will be opened on the same day at 1530 hrs. by the Executive Engineer, Roing PW Division or an authorized representative of the Executive Engineer, Roing PW Division, in the presence of the bidder(s) or authorized representative(s) of the bidder(s) who wish to attend. If the office happens to be closed on the last date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. "Technical Bids" shall be evaluated by a screening/evaluation committee at the Division/Circle/Zonal office whose decision shall be final as the case may be, and the bidder(s) who qualify shall be invited to attend the opening of "Financial Bids" for which the date and venue will be intimated later on.
- Prospective bidders are hereby informed that Administrative Approval and Expenditure Sanction of the projects are awaited from the competent authority. This IFB has been called to expedite the tender formalities in anticipation of receipt of sanction. However, in the event that all the tender formalities are completed before the Administrative Approval and Expenditure Sanction are accorded by the competent authority, the award of work to the successful bidder shall be kept on hold and will be done only after receipt of the Administrative Approval and Expenditure Sanction from the competent authority. The Department shall have no responsibility to any liability /obligation of the prospective bidder on account of any delay in award of work for such reason(s). This point should be carefully taken note of by the bidders.


5. The Employer reserves the right to accept or reject any bid, and to cancel the bidding process and reject all bids, at any time prior to the award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform affected bidder or bidders of the grounds for the employer's action.
6. The successful bidder will do the design and the development of detailed structural drawings and also get them proof checked by IIT, Guwahati/Kharagpur/Delhi/Bombay/Madras. Any survey and subsoil investigation that may be necessary prior to taking up the design and the development of structural drawings will also be done by the successful bidders. The expenses on all these activities will be treated as an integral part of the overall bid /tender for the work and will be borne by the successful bidder. No claim(s) for reimbursement(s) or otherwise whatsoever, on this count will be entertained by the Department. The design and the detailed structural drawings, duly proof - checked, will be furnished to the department by the successful bidder within one (1) month of acceptance of the bid.
7. A pre-bid meeting will be held on 03/12/2014 at 1130 hours in the office of the Superintending Engineer, Tezu PW Circle, AP/ Executive Engineer, Roing PW Division, AP, to clarify issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of "Instructions to Bidders" of the bidding document.
8. The bidder who fulfills the following initial requirements shall only be eligible to participate.
 - a) Experience of having successfully completed one building project/building projects of aggregate cost not less than Rs. 1212.50 Lakhs during the last 5 years ending last day of August 2014. Preference will be given to the bidders who has/have completed a similar work/ works.
 - b) Has an annual financial turn over in civil engineering construction works in any one year during the last five (5) years ending March 2014 of value not less than Rs. 2425.00 Lakhs.
9. The bidder will have to submit a No Dues Certificate (NDC)/No Objection Certificate (NOC) from the Arunachal Pradesh State Co-operative Apex Bank Limited, duly issued by the Managing Director cum Chief Executive Officer, Itanagar along with the bid. The NDC / NOC whose validity has expired will not be accepted.
10. Other details and other documents to be submitted will be as described in the bidding document.
11. The bidder, at the bidder's own responsibility and risk is encouraged to visit the project site and obtain necessary information related to it to facilitate preparation of the bid.
12. In the event of more than one qualified bidder quoting the same amount, the award of work shall be determined by the Bid Capacity of the bidders, inclusive of conditions of clause 4.8 of ITB.
13. Any contractor who has two (02) or more uncompleted ongoing commitments (projects to execute/ contracts at hand) is not permitted to participate in this bidding. A bidder will invariably submit an affidavit sworn before a competent magistrate to the effect that he does not have two (02) or more uncompleted ongoing commitments at the time of bidding. The affidavit should mention the names of the uncompleted ongoing commitments. Any bid which does not fulfill this condition will summarily be rejected. In the event of submission of false information, which may be detected by the department after award of works, the tender shall be cancelled immediately & the contractor shall be barred from further participation in any tender(s) of the Department.
14. The information/documents mentioned in (8), (9), and (10) above should be submitted in an orderly manner as and where required by indexing them as detailed in the relevant section(s) of the Bidding Document. The guarantees, certificates, etc from bank(s) and other authorities and other information shall be furnished strictly repeat strictly as per the standard forms given in the relevant section (s) of the Bidding Document. They must not be older than three (3) months and must be signed by the competent authority himself /herself with proper official seal. Non-compliance on these counts may lead to rejection of bid on account of non-responsiveness.

15. Any corrections or additions that may become necessary shall be notified through corrigenda or addenda or in the pre-bid meeting(s) in due course of time.
