The Chief Engineer, PWD, Eastern Zone invites bids/ tenders on behalf of the Governor of Arunachal Pradesh for execution of works on Turnkey basis from registered contractors of appropriate class as detailed below. The Department will not be held responsible for postal delays, if any, in the delivery of the documents or non-receipt of the same.
2. Bids must be accompanied by Bid Security/ Earnest Money of the amount specified for the work in the table above, payable at the **State Bank of India, Khonsa drawn in favour of Executive Engineer, Khonsa P.W Division**. Bid Security/Earnest Money will have to be in any one of the forms as specified in the Bidding Document and shall have to be valid for 45 days beyond the validity of the bid.
3. Bids under two separate sealed covers for individual packages superscribed as **"Technical Bid"** and **"Financial Bid"** must be delivered to the **Executive Engineer, Khonsa PW Division**, on working days and latest by 1500 hrs. on or before **15/07/2014**. The **"Technical Bid"** will be opened on the same day at 1530 hrs. by the **Executive Engineer, Khonsa PW Division** or an authorized representative of the **Executive Engineer, Khonsa PW Division**, in the presence of the bidder(s) or authorized representative of the bidder(s) who wish to attend.. If the office happens to be closed on the last date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. **"Technical Bids"** shall be evaluated by a screening/evaluation committee at the Division/Circle/Zonal office whose decision shall be final as the case may be, and the bidder(s) who qualify shall be invited to attend the opening of **"Financial Bids"** for which the date and venue will be intimated later on.

The Employer reserves the right to accept or reject any bid, and to cancel the entire bidding process and reject all bids, at any time prior to the award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform affected bidder or bidders of the grounds for the Employer's action.

A pre-bid meeting will be held on **11/07/2014** at 1130 hours in the office of the **Superintending Engineer, Jairampur PW Circle, A.P / Executive Engineer, Khonsa PW Division, A.P**, to clarify issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of "**Instructions to Bidders**" of the Bidding Document.
6. The bidder who fulfills the following initial requirements shall only be eligible to participate.
 - a) Experience of having successfully completed atleast one building project/building projects whose aggregate cost is not less than **₹ 920.00 Lakhs** during the last 5 years ending last day of May'2014. Preference will be given to those bidders who have completed **similar work(s)**.
 - b) Has an annual financial turn over in Civil Engineering construction works in any one year during the last five (5) years ending March, 2014 of value not less than **₹ 1840.00 Lakhs**.
7. The bidder will have to submit a No Dues Certificate (NDC)/No Objection Certificate (NOC) from the Arunachal Pradesh State Co-operative Apex Bank Limited, not older than three (3) months, duly issued by the Managing Director cum Chief Executive Officer, Itanagar along with the bid.
8. Other details and other documents to be submitted will be as described in the Bidding Document.
9. The bidder, at the bidder's own responsibility and risk is encouraged to visit the project site and obtain necessary information related to it to facilitate preparation of the bid.
10. In the event of more than one qualified bidder quoting the same amount, the award of work shall be determined by the Bid Capacity of the bidders, inclusive of conditions of clause 4.8 of ITB.
11. The information/documents mentioned in (7), (8) and (9) above should be submitted in an orderly manner as and where required by indexing them as detailed in the relevant section(s) of the Bidding Document. **The guarantees, certificates, etc from bank(s) and other authorities and other information shall be furnished strictly as per the standard forms given in the relevant section (s) of the Bidding Document.**
