The Earnest Money of the amount specified above in the form of Fixed Deposit Receipt/Term Deposit Receipt in favour of the Executive Engineer, PWD, Ziro should be enclosed with the Tender document in separate sealed cover, the Tender will be opened on the same day at **1500 hrs** in the office of the Superintending Engineer, Yachuli Civil Circle, PWD, AP, Camp Naharlagun by him or his authorized representative in the presence of intending tenderers.

The intending Firms/Contractors should furnish a No-Due Certificate (NDC) from Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issued on or after **31-03-2015** by the Managing Director Cum Chief Executive Officer, Naharlagun. No Tender Paper shall be issued to any intending bidder without submission of NDC from Arunachal Pradesh State Cooperation Apex Bank Ltd.
