The Tender will be opened on the same day on **15/02/2020** at **1500 hrs** in the office of the **Executive Engineer, Kanubari Division, PWD, AP, Kanubari** by him or his authorized representative in the presence of intending tenderers.

The intending Firms/Contractors should furnish the No-Due Certificate (NDC)/ No Objection Certificate (NOC) from Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issued on or after **31/01/2020** by the Managing Director Cum Chief Executive Officer, Naharlagun in order to qualify. No Tender Paper shall be issued to any intending bidder without submission of NDC/NOC.
8. The intending Firms/Contractors should submit GST registration.
9. The Tender without earnest money in proper form shall be summarily rejected.
