The intending Firms/Contractors should furnish No-Due Certificate (NDC)/ No Objection Certificate (NOC) from Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issued by the Managing Director Cum Chief Executive Officer, Naharlagun Arunachal Pradesh in original at the time of applying for bidding document. have been issued on or after **01/03/2016**). No tender paper shall be issued to any intending bidders without submission of NOC.

The Earnest Money of the amount specified above in the form of Fixed Deposited receipt/Term Deposit receipt of a Scheduled Bank guaranteed by the Reserved Bank of India issued in favour of Executive Engineer Tali Division, PWD Payable at State Bank of India, Ziro Branch should enclosed with the Tender document in separate sealed envelope.
- 6. The participants must submit proof of having technical personnel with proof of qualification, experience, age, address etc. as required under SCHEDULE "F", page 110 of the tender document in accordance with Clause-36(i) of conditions of contract without which tender shall be rejected.
- 7. The participants must submit proof of possessing T&Ps as required under SCHEDULE- "F", page 112 of the tender document in accordance with Clause-18 of conditions of contract without which tender shall be rejected.
- 8. The intending Firms/Contractor should submit Income Tax clearance Certificate/Income Tax Exemption Certificate, V.A.T Clearance Certificate for the preceding financial year and Employees Provident Fund Registration Certificate.
- 9. Other document/information required to be furnished by the tenderers are described in the Tender documents.
- 10. Tenderers are advised to inspect the site and its surroundings and satisfy themselves before submitting their bids.
- 11. The Tender without earnest money in proper form shall be summarily rejected.
- 12. The i) Tender paper ii) Profile of the firm and iii) Earnest Money should be packed and sealed (by sealing wax) in three separate envelopes super scribing/marking as tender paper/profile of the firm and Earnest Money. These three envelopes "(called as inner envelopes) shall then be put inside one outer envelope and sealed by sealing wax duly super scribing/marking as Tender for the work "XXXXXXXXXX" "(Package/NIT No. XXXXXXXXXX)". The bid received unsealed shall be rejected.
- 13. Use of correction fluid, anywhere in tender document is not permitted. Such tender is liable for rejection as per general rules and direction **No 9A page 11** of tender document.

In case of any correction in figure and word, the same should be signed by the authorized signatory of the firm/contractor. The financial figure in word shall be taken as final.
