The Executive Engineer, Roing Division, PWD, AP, Roing on behalf of the Governor of Arunachal Pradesh, invites **Online item rate tenders in single bid system** from all registered contractors in appropriate Categories of APPWD and those of appropriate class with CPWD/NEEPCO/BRO/MES/RAILWAYS etc as per Arunachal Pradesh District Based Entrepreneurs and Professionals (Intensives, Development and Promotional) Act 2015 (Act No. 05 of 2015) for the work as detailed below.

- The eligibility of contractor shall be strictly as per rule and condition notified vide NO. SPWD/W-66/2012 /314 dtd 13.08.2015 and published in AP Gazette vide No 224 Vol XXII September 11<sup>th</sup> 2015.
- Contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are not accepted:-
  - Should have completed three Similar nature of works each of value 40% or two Similar nature of work of value 60% or one similar nature of works value of 80% during last five year.
  - Should have had an average annual financial turnover of 50% in construction works during last three years upto 31.3.2017.
  - Should have a Bank Solvency ( 40% as per CPWD Manual Appendix-20(E) or financial soundness certificate (Scanned copy of original solvency to be uploaded).
  - The bidder shall have to submit Credit facility from Bankers of 10% of tender value.
  - The bidder shall have to submit an affidavit to invest up to 25% of tender value.
- The intending bidders must read the terms and conditions of CPWD-6. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.

4. Information and instructions for bidders posted on website shall form part of Bid documents.
5. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be downloaded from website <https://pwdar.etenders.in>
6. But the bid can only be submitted after depositing processing fee in favour of M/s Nex tenders (India) Pvt. Ltd., and uploading the mandatory scanned documents such as Demand draft or Bankers cheque or Fixed deposit receipt of any scheduled bank towards EMD in favour of Executive Engineer, Roing Division, PWD,AP, Roing and other documents as specified.
7. The intending bidder must have valid Digital Signature to submit the bid.
8. Contractor can upload documents in the form of PDF and JPEG format.
9. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue.

In addition to this while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as '0'.


Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (Zero).

10. Entire document related to Eligibility Criteria, Technical Bid and Financial Bid are to be uploaded.

(I) **Technical Bid:** Documents uploaded by the contractors related with Eligibility Criteria are opened first. Documents related to eligibility criteria comprising of: -

- (a). Full details of firm, Status of Company (Proprietorship/ private limited/ limited etc).
- (b). Copy of contractor registration certificate.
- (c). An affidavit signed by the Magistrate declaring the following Information.
  - (i). Name, address and contact number of the establishment under which the contractor is enlisted.
  - (ii). Contractor enlistment no. and Sl. No. of enlistment.
  - (iii). Web site address of the registering authority for online verification.
- (d). In case of power of Attorney holder representing the firm, shall also submit an affidavit in par with the proprietor.
- (e). No due certificate (NOC) from Apex Bank issued by Managing Director (Applicable for AP Registered contractors).
- (f). GST registration certificate and PAN card.
- (g). Address proof for communication and mobile number.
- (h). Employees Provident Fund (EPF) registration certificate.
- (i). Financial turn over for the last 3(three) years.
- (j). Profit & loss statement for the past three years.
- (k). Bank solvency certificate.
- (l). Credit facility certificate from Bankers.
- (m). Affidavit to invest cash upto 25% of tender value.
- (n). List of key items of contractor's equipment for carry out the work.
- (o). Ownership certificate of mandatory machinery, tools & plants to be deployed by the contractor at site as mentioned in Schedule A to F.

- (p). Name and address of Site Engineer having the qualification with required experience as shown in the bidding document.
  - (q). Certificates of qualification and experience of key personal required for and administration & execution of the contract.
  - (r) PRC/ Domicile certificate and Voter ID Card.
- (II) **Financial Bid:** Financial bids may be opened on same date and time.  
Financial bid comprising of: -
- (a). Financial bid/ price bid in the format as indicated in the tender document.
11. The documents related with financial capabilities to be uploaded are very bulky and after scanning it becomes quite big file. Therefore, at the time of submission of bid contractor may upload affidavit/certificate from CA mentioning financial turnover of last 5 years or for the period and further details if required can be asked from contractor later on after opening of technical bid.
  12. The Hard copy of Technical bid uploaded is required to be submitted to the office of the Executive Engineer, Roing Division, PWD AP, Roing before **1430 hrs of 09.03.2018**. Need not to submit hard copy of financial bid.
  13. A pre-bid meeting will be held on **05.03.2018 at 1100 hrs** at the office of the Executive Engineer, Roing Division, PWD,AP, Roing to clarify the issues and to answer question on any matter that may raised at that stage as stated in instruction to Bidders of the Bidding documents.
  14. Bid online must be accompanied by Earnest Money and cost of tender documents specified for the work in the table above, in the form of receipt Treasury Challan / Fixed deposit of a schedules bank/ Bankers Cheque issued in favour of Executive Engineer, Roing Division, PWD,AP, Roing, payable at SBI Roing.
  15. The competent authority on behalf of the Governor of Arunachal Pradesh does not bind itself to accept the lowest or any other tender and reserves the right to accept or reject any or all the tenders received without assigning and reason.
  16. The competent authority on behalf of the Governor of Arunachal Pradesh reserve the right to accept or reject any bid, and to cancel the bidding process and reject all bids, at time prior to the award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform to bidder or bidders of the grounds.
  17. As provided for in Article 5 (3) of the integrity pact, any bidder who does not submit the integrity pact between the Principal/ owner (Executive Engineer, Roing Division, PWD) and the Bidders/ Contractor along with the bid / tender, will be disqualified from the tender process by the Principal / owner ( Executive Engineer, Roing Division, PWD).
