The Executive Engineer, Daporijo Division, PWD, AP, Daporijo on behalf of the Governor of Arunachal Pradesh, invites Sealed Item rate Tender from registered and eligible contractors of class -IV & III Categories under Arunachal Pradesh Contractor Enlistment Rule-2008, domiciled within the Territorial Jurisdiction of 25<sup>th</sup> Raga (ST) Assembly Constituency for the following below Work :

The applications not supported with requisite experience certificate shall not be entertained.  
**Note : Similar works mean "Road works such as FC, cross drainage, pavement etc."**
- The participants must submit proof of possessing T&Ps as required under **SCHEDULE-"F"**, page 10 of the tender document in accordance with Clause-18 of conditions of contract without which tender shall be rejected.
- The participants must submit proof of having technical personnel's with proof of qualification, experience, age, address etc. as required under **SCHEDULE - "F"**, page 11 of the tender document without which the tender shall be rejected.

The intending Firms/Contractors should furnish the No-Due Certificate (NDC)/ No Objection Certificate (NOC) from Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issued by the Managing Director Cum Chief Executive Officer, Naharlagun in order to qualify. (The Certificate should have been issued on or after **30/01/2016**)
9. The intending Firms/Contractor should submit Income Tax clearance Certificate for the last one year or Income Tax exemption certificate as the case may be.
10. Other document/information required to be furnished by the tenderers are described in the Tender documents.
11. Tenderers are advised to inspect the site and its surroundings and satisfy themselves before submitting their bids
12. Preference will be given to the semi Government organization/Govt. undertaking having experience in the field of Civil Construction works and other related activities
