3. Permanent Residence Certificate duly issued by the competent authority to be submitted in proof of Assembly Constituency.
4. Tender documents will be issued to eligible contractors from 05.10.2017 to 07-10-2017 during office hours provided they produce definite proof of registration/enlistment from the appropriate authority, which shall be to the satisfaction of competent authority.
5. Earnest money as mentioned in Column No. 4 of above table should be deposited along with the tender documents in separate envelope marked as Earnest Money in form of Receipt /Treasury challan/ Deposit at call receipt of a scheduled bank / fixed deposit receipt of a scheduled bank/Demand Draft of a Scheduled bank issued in favour of Executive Engineer, Aalo PWD Division.
6. NDC /NOC from the Managing Director, Co-op Apex Bank, Naharlagun, Arunachal Pradesh is to be produced.
7. The intending registered contractors should fulfill following criteria:-
- Three similar works each of value not less than ₹. 57.97 Lakhs (40%) or two similar work each of value not less than ₹. 72.47 Lakhs (50%) or one similar work of value not less than ₹. 115.94 Lakhs-(80%) in last 5 years ending last day of the month previous to the one in which the tenders are invited.
  - Should produce average Annual financial Turnover ₹. 72.47 Lakhs (50%) on construction work during last 3 (three) years ending 31<sup>st</sup> March'2017.

9. Once Tender Papers issued in favour of particular name/firm shall not be change in any circumstances. The undersigned reserve the right to accept/reject any or all the application without assigning any reason thereof.
10. GUARANTEE PERIOD: - Repair & maintenance or rectification of work shall be done by the contractor within 1(one) year or 1(one) rainy season after expiry of the date of completion of work.
11. Eligibility: - All registered contractors in Class-III Category domiciled within the territorial jurisdiction of West Siang District, Arunachal Pradesh.
12. The intending tenderer shall be allowed to have only 2(two) works in hand in any departments under Government of Arunachal Pradesh at a time and for which he/she shall make a declaration to be executed in an affidavit that he/she is not engaged in more than two any tender works under state government. He/she shall also submit completion certificate issued by the engineer in-charge duly countersigned by the Concerned Superintending Engineer and Chief Engineer.
13. Tender documents shall be issued to prospective bidders only on production of original enlistment/registration for verification of authenticity of the bidders.
14. Bidder should produce original documents during Bid opening. Only the Bidder or his authorized representative along with authorization letter duly signed with firm seal of the bidder shall be allowed to witness the Bid opening process.
