The Executive Engineer Yingkiong Division, PWD, AP, Yingkiong invites Tender on behalf of Governor of Arunachal Pradesh on item rate basis for the construction of works as detailed below, from registered contractors of Class-II categories domiciled within the territorial jurisdiction of 34 Tuting-Yingkiong Assembly Constituency in accordance with Govt. Notification No. SPWD/W-66/2012/314 Dtd.13/08/2015.

However, registered eligible contractors of Upper Siang District can also participate in the tender at their own risk and cost and their case would be consider for scrutiny only when participation will be less than 2(two) eligible domiciled tenderers of 34th Tuting-Yingkiong Assembly Constituency.

Tender documents (and additional copies) may be purchased from the office of Executive Engineer, Yingkiong Division, PWD, AP, Yingkiong from **24.07.2018 to 06.08.2018** upto to **1600** hours for a non-refundable fee as indicated, in the form of cash or Demand Draft on any Scheduled bank payable at State Bank of India, Yingkiong Branch in favour of Executive Engineer, Yingkiong Division, PWD, AP, Yingkiong. Interested tenderers may obtain further information at the same address. Tender documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs 500.00 (Rupees Five hundred) only. The Executive Engineer, Yingkiong Division, PWD, AP, Yingkiong will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
2. Tender must be accompanied by security of the amount specified for the work in the table, payable at State Bank of India, Yingkiong Branch and drawn in favour of Executive Engineer, Yingkiong Division, PWD, AP, Yingkiong. Tender security will have to be in anyone of the forms as specified in the tender document and shall have to be valid for **45 (Forty Five) days** beyond the validity of the tender.
3. Tender in single envelop covers must be delivered to Executive Engineer, Yingkiong Division, PWD, AP, Yingkiong on working days and latest by 1500 hours on or before **09.08.2018**. The "Tender" will be opened on the same day at **1530** hours, in the presence of the tenderers who wish to attend. If the office happens to be closed on the date of receipt of the tender as specified, the tender will be received and opened on the next working day at the same time and venue. Tender shall be evaluated by a standing Screening Committee whose decision shall be final.



4. The tenderer who fulfills the following initial requirements shall only be eligible to participate
 - a) Should have executed three similar work each of value not less than 40% of estimated cost or two similar works each of value not less than 60% of the estimated cost or one similar work of value not less than 80% of estimated cost (rounded to nearest of 10.00 lakh) in last 5 year ending last date of the previous month in which tender are initiated for the purpose of clause similar work meaning the work of Roads works.
 - b) Should have had an annual financial turn over in civil engineering construction works in any one year during the last 5(five) years ending March'2018 of value not less than Rs. 350.00 Lakh (Rupees Three Hundred Fifty Lakh) only.
5. Any contractor who has 2 (two) or more uncompleted ongoing commitment (projects to execute/contracts at hand) is not permitted to participate in this tendering. A tenderer will invariably submit an affidavit sworn before a competent Magistrate to the effect that he does not have 2 (two) or more uncompleted ongoing commitments at the time of tendering. The affidavit should mention the names of the uncompleted ongoing commitments. He shall also, for participation in any tender be required to submit completion certificate issued by the Engineer-in-charge duly counter signed by the concerned Superintending Engineer. Any tender which does not fulfill this condition will be summarily rejected. In the event of submission of false information, which may be detected by the department after award of work, the tender shall be cancelled immediately and the contractor shall be barred from further participation in any tender works of the department.
6. The tenderer will have to submit **No Due Certificate (NDC) / No Objection Certificate (NOC)** from Arunachal Pradesh State cooperative Apex bank Limited, not older than 3(three) months, duly issued by the Managing Director cum Chief Executive Officer , Itanagar along with the tender.
7. All the required information and documents should be submitted strictly in the formats given in the tender document. Other standard formats may be adopted only in cases where no formats have been prescribed in the Tender document.
8. All affidavits, undertakings, agreements etc. should invariably be sworn before a magistrate and they should be specific.
9. No attested copies of documents that ought to be submitted in original shall be accepted.
10. The tenderer, at the tenderer's own responsibility and risk is encouraged to visit the work site and obtain necessary information related to it to facilitate preparation of the tender.
11. In the event of more than one qualified tenderer quoting the same amount, the award of work shall be determined by the Tender capacity of the tenderers.
12. All the requisite information/documents mentioned in (6), (7), (8) and (9) above should be submitted in an orderly manner as and where required by indexing them as detailed in the relevant section(s) of the tendering document. The guarantees, certificates, etc from bank(s) and other authorities and other information shall be furnished as per the standard forms given in the relevant section(s) of the Tender Document. They must not be older than three (3) months and must be signed by competent authority himself/herself with proper official seal.



13. The tender has been floated in anticipation of sanction of scheme. The work shall be awarded only after obtaining formal sanction from the state Govt. Accordingly, if required bid validity shall have to be extended as required by the department and the item rate quoted shall be final and any enhancement on items shall not be entertained.
14. The Employer reserves the right to accept or reject any tender, and to cancel the tendering process and reject all tenders, at any time prior to the award of contract, without thereby incurring any liability to the affected tenderer or tenderers or any obligation to inform affected tenderer or tenderers of the grounds for the employer's action.
