- Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development & and Promotional) Act 2015 & subsequent amendments published vide Notification published in Arunachal Pradesh Extra Ordinary Gazette vide No. 247 Vol-XXVII, dated 2nd November 2020 shall be mandatorily applicable.
- 2. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- 3. Information and instructions for bidders posted on website shall form part of bid document.
- 4. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website https://arunachaltenders.gov.in.
- 5. But the bid can only be submitted after deposition of original EMD in the office of the Executive Engineer, Sangram PWD Division, Sangram (AP) within the period of bid submission and uploading the mandatory scanned documents such as Insurance Surety Bonds, Account Payee Demand draft or Bankers Cheque or Fixed Deposit Receipts or/ and Bank Guarantee (for balance amount as prescribed) from any of the Commercial Bank towards EMD in favour of Executive Engineer, Sangram PWD Division, Sangram (AP) as mentioned in NIT, receipt for deposition of original

- EMD to the Executive Engineer, Sangram PWD Division, Sangram (AP) (including NIT issuing EE/AE), and other documents as specified.CPWD-6, Proforma of Schedules A to F, Special conditions, Specifications and Drawings only will be uploaded to tendering website. The GCC-2019 (standard form) will not be uploaded along with the Tender documents but the same shall form part of the agreement to be drawn and signed by both parties after acceptance of tender.
- 6. Those contractors, who are not registered or have not updated their profile on the website mentioned above, are required to get registered / update their profile beforehand. The necessary training materials including the videos with step to step process are available on download section of https://etender.cpwd.gov.in
- 7. The intending bidder must have valid Class-III digital signature certificate with encryption key (combo type) to perform any operations / transactions on the e-tendering portal / website and the bidder should download and install the eMsigner on their system as per instructions available on download section of https://etender.cpwd.gov.in.
- 8. On opening date, the contractor can login and see the bid opening process. After opening of bids, he will receive the competitor bid sheets
 - Contractor can upload documents in the form of JPG format and PDF format.
- 9. Contractor must ensure to quote rate in the prescribed column(s) meant for quoting rate in figures appears in yellow Colour and the moment rate is entered, it turns sky blue. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO). However, If a tenderer quotes nil rates against each item in item rate tender or does not quote any percentage above/below on the total amount of the tender or any section / sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer

10. Criteria of eligibility:

In the larger interest of the public and for equitable distribution of development works amongst eligible contractors and also to ensure effective management and quality of works, a contractor shall be allowed to have maximum number of only 3 (three) existing works in hand in any of departments under Government of Arunachal Pradesh at a time and for which he shall make a declaration to be executed in an Affidavit that he is not presently engaged in more than 2 (two) tenders works under the State Government of Arunachal Pradesh, to be eligible to participate in this tender work.

- 11. The Requisite criteria for work experience credential in the last 7 (Seven) years ending last day of the month before the one in which the tenders are invited shall be as under –
- (i) Construction Works with 3 (Three) similar works each of value not less than (40% of estimated cost), OR,
- (ii) Construction Works with 2(Two) similar works each value not less than (60% of estimated cost), OR,
- (iii) Construction Works with 1(One) similar work of value not less than (80% of estimated cost).

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of receipt of applications for tender.

- 13. For the purpose of this clause 'Similar works' means the works of 'Construction of Roads and Bridges'.
