Bids under two separate sealed covers for individual packages superscribed as "Technical Bid" and "Financial Bid" must be delivered to the Executive Engineer, Roing PW Division, on working days and latest by 1500 hrs on or before 21.01.2014. The "Technical Bid" will be opened on the same day at 1530 hrs by the undersigned or an authorized representative of the undersigned in the presence of bidder(s) or authorized representative of the bidder(s) who wish to attend... If the office happens to be closed on the last date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. "Technical Bids" shall be evaluated by a screening / evaluation committee whose decision shall be final and the bidder(s) who qualify shall be invited to attend the opening of "Financial Bids" for which the date and venue will be intimated later on.
- 4. Prospective bidders are hereby informed that Administrative Approval and Expenditure Sanction of the project is awaited from the competent authority.  - b) Has an annual financial turn over in civil engineering construction works in any one year during the last five (5) years ending March, 2013 of value not less than ₹ 2127.50 Lakhs.
- The bidder will have to submit a No Dues Certificate (NDC)/No Objection Certificate (NOC) from the Arunachal Pradesh State Co-operative Apex Bank Limited, duly issued by the Managing Director cum Chief Executive Officer, Itanagar along with the bid.
