
NOTICE INVITING TENDER

The Executive Engineer, Palin Division, PWD, AP, Palin on behalf of the Governor of Arunachal Pradesh, invites sealed items rate tenders in CPWD Form 8 from the eligible contractors of APPWD and those of appropriate class as per Arunachal Pradesh District Based Entrepreneurs & Professional (Incentive, Development & Promotional) (AMENDMENT) Act No.7 of 2020 for the work as stated below:-

3. Tender shall be received by the undersigned upto **1030 hrs of 13/01/2023** and shall be **opened on the same day at 1130 hours** in presence of intending contractor(s) or his (their) authorized representatives.
4. The Earnest Money shall be deposited in the Scheduled Bank and receipted Treasury Challan/Deposit at Call Receipt of a Scheduled Bank/Fixed deposit receipt of a scheduled Bank/Demand Draft of a Scheduled Bank guaranteed by the Reserve Bank of India issued in favour of **Executive Engineer, Palin Division, PWD, AP, Palin payable at State Bank of India, New Palin Branch, Code-7874** which should accompany with the Tender documents.
5. The Contractors/tenderers should furnish the following initial requirements along with application form and requisite cost of tender documents for issue of tender documents to participate:
- a) The bidders should have satisfactorily completed similar single work costing not less than (80% of cost put to tender) or Two similar works each costing not less than (60% of


- cost put to tender) or Three similar works (in Central Government Department/State Government Department/Central Autonomous Body/Central Public Sector Undertaking) each costing not less than (40% of cost put to tender) during last 5(Five) year ending last day of March'2022.
- b) Solvency certificate of value not less than 40% of Amount put to tender certified by a Nationalized bank.
 - c) The bidder should furnish PAN card, GST Registration Certificate along with monthly return filed latest by Dec'2022 in form GSTR-3B.
 - d) The applicant shall submit valid No-Dues certificate (NDC)/No Objection Certificate (NOC) from Arunachal Pradesh State Co-operative Apex Bank Limited duly issued by the Managing Director cum Chief Executive Officer, Naharlagun/Itanagar in order to participate.
 - e) The applicant must submit valid Contractor Enlistment/Registration Certificate of specified class.
 - f) The Contractor must demonstrate of his proof of domicile in the concerned territorial jurisdiction by submitting a bonafide PRC/Epic Card.
6. The tenders without Earnest Money shall be summarily rejected.
 7. Contractors have to fulfill all requirements as specified in the special conditions of contract. Non fulfillment of same may be summarily rejected.
 8. The undersigned reserves the right to accept/reject any or all the tenders without assigning any valid reason thereof.
