The Executive Engineer, Ziro Division, PWD, AP, Ziro on behalf of the Governor of Arunachal Pradesh, invites Sealed Item rate Tender from registered and eligible contractors of appropriate class enlisted with CPWD, AP PWD, Telecommunication, Railways, MES and other State PWD for the work stated below :

1. **Eligibility Criteria :** The participants must have successfully executed in Central/State Govt./PSU's three similar works each of value 40% of the estimated cost or two similar works each of value 60% of the estimated cost or one similar work of value 80% of the estimated cost during last five years. The applications not supported with requisite experience certificate shall not be entertained.

Note : Similar works mean "Multistoried RCC Building".

2. The participants must submit proof of possessing T&Ps as required under **SCHEDULE-"F"**, page 88 of the tender document in accordance with Clause-18 of conditions of contract without which tender shall be rejected.
3. The participants must submit proof of having technical personnel's with proof of qualification, experience, age, address etc. as required under **SCHEDULE - "F"**, page 89 of the tender document without which the tender shall be rejected.

(The Certificate should have been issued on or after **30/09/2014**)
8. The intending Firms/Contractor should submit Income Tax clearance Certificate for the last one year or Income Tax exemption certificate as the case maybe.
