The Tender will be opened on the same day i.e. **20-09-2021 at 1500 hrs** in the office of the Executive Engineer, Ziro Division, PWD, AP by him or his authorized representative in the presence of intending tenderers.

4. The Earnest Money of the amount specified above in the form of Demand Draft/Banker Cheque/Fixed Deposit Receipt/Term Deposit Receipt in favour of the Executive Engineer, PWD AP, Ziro should be enclosed with the Tender document in separate sealed cover.

6. The intending Firms/Contractor should submit Income Tax clearance Certificate for the last one year or Income Tax exemption certificate as the case may be.
7. Other document/information required to be furnished by the tenderers are described in the Tender documents.
8. Bidders are advised to inspect the site and its surroundings and satisfy themselves before submitting their tenders.
