**NOTICE INVITING TENDER**

The Executive Engineer, Ziro Division, PWD, AP, Ziro on behalf of the Governor of Arunachal Pradesh, invites Sealed Item rate Tenders from registered contractors in Class-I category enlisted under the Arunachal Pradesh Contractors Enlistment Rules-2008 and domiciled within the territorial jurisdiction of the District under which the work is to be executed for the work stated below :

- 1. Eligibility Criteria :** The participants must have successfully executed in Central/State Govt./PSU's three similar works each of value 40% of the estimated cost or two similar works each of value 60% of the estimated cost or one similar work of value 80% of the estimated cost during last five years. The applications not supported with requisite experience certificate shall not be entertained.  
**Note :** Similar works mean "Road works such as FC, cross drainage, pavement etc.".
- 2. Tender paper can be purchased from the Executive Engineer, Ziro Division, PWD, Ziro on all working days by submitting Application along with requisite experience certificate and on payment of cost of Tender Paper in cash (non-refundable) from 17/02/2016 to 22/02/2016 (up to 1600 hrs). Tender Paper requested by mail/post will be dispatched by registered/speed post on payment of an extra amount of Rs.1000/-. The department will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.**
- 3. Tender must be delivered to the Executive Engineer, Ziro Division, PWD, AP, Ziro on or before 1130 hrs on 26/02/2016.**
- 4. The Earnest Money of the amount specified above in the form of Fixed Deposit Receipt/Term Deposit Receipt in favour of the Executive Engineer, PWD AP, Ziro should be enclosed with the Tender document. The Tender will be opened on the same day i.e. 26/02/2016 at 1500 hrs in the office of the Executive Engineer, Ziro Division, PWD, AP by him or his authorized representative in the presence of intending tenderers.**
- 5. The intending Firms /Contractors should furnish the No Due Certificate (NDC)/ No Objection Certificate (NOC) from Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issued by the Managing Director Cum Chief Executive Officer, Naharlagun. No Tender Paper shall be issued to any intending bidder without submission of NDC. (The Certificate should have been issued on or after 01/10/2015).**

6. The intending Firms/Contractor should submit Income Tax clearance Certificate for the last one year or Income Tax exemption certificate as the case may be.
7. Other document/information required to be furnished by the bidders are described in the Tender documents.
8. Bidders are advised to inspect the site and its surroundings and satisfy themselves before submitting their bids
9. The Tender without earnest money in proper form shall be summarily rejected.
10. The competent authority reserved the right to reject any or all the Tender without assigning any reason.
11. The Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and Promotional) Rules 2015 as notified vide No. SPWD/W-66/2012/314, dated 13/8/2015 shall be applicable in this tender.
12. The APST contractors shall submit ST Certificate to avail relaxation of Earnest Money in favour of them. Original ST Certificate should be produced at the time of opening of the Tender. No relaxation shall be admissible without submission of ST Certificate.
