The Executive Engineer, Capital Division-A, PWD, Arunachal Pradesh, Itanagar, on behalf of the Governor of Arunachal Pradesh invites online item rate tender from all eligible registered contractors in **Class-I** categories domiciled within the territorial jurisdiction of the District **Papumpare** and shall be governed by the provision defined under Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development & Promotional) Act 2015 with up-to-date Amendment Act, 2020 notified in Arunachal Pradesh Extra-Ordinary Gazette vide No. 247, Vol-XXVII, dated 2nd November 2020 for following work:

The bids can be submitted in electronic format in the website <https://arunachaltenders.gov.in> within the specified time by paying **Bid Fee (non-refundable)** in the form of demand draft of ₹2000/- (Rupees two thousand) only drawn in favour of "Executive Engineer, Capital Division-A, PWD, Arunachal Pradesh, Itanagar" payable at any scheduled Bank, at Itanagar for the work listed in the tender. *(The copy of Bid Fee document and receipt of Bid Fee shall also be scanned and uploaded to the e-tendering website by the intending bidders within the specified bid submission date and time).*

Before submission of online bids, the bidders must ensure that the scanned copy of all the necessary documents have been attached with the Bids. The details of the cost of documents and the Bid Security specified in the tender document should be same as submitted online (Scanned copies), otherwise will be summarily rejected. The department does not take any responsibility for delay caused due to non-availability or slow internet connection or network, traffic jam etc. for online bids.

4. Initial Criteria of eligibility for submission of bid documents for **APPWD** as well as **Non-APPWD** contractors:

- (a) The bidder should not have more than 2 (two) existing tender works in any of departments under Government of Arunachal Pradesh for which he shall make a declaration to be executed in an Affidavit that he is not engaged in more than two tender works under the State Government of Arunachal Pradesh. *(Affidavit shall be signed before First Class Magistrate).*
- (b) The Bidder should have satisfactorily completed 3 (three) similar works each of value not less than ₹585.00 lakh (40% of estimated cost put to tender) or 2 (two) similar works each value not less than ₹877.00 lakh (60% of estimated cost put to tender) or 1 (one) work of value not less than ₹1170.00 lakh (80% of estimated cost put to tender) during the last 7 (seven) years ending last day of month previous to the one in which tenders are invited.

For the purpose of this clause 'similar work' means the works of "**Construction of RCC framed structure multi-storied buildings involving E&M with minimum one building of five storeys (G+4) or completing balance construction work of one building (i/c structural work) minimum upto five storey**". The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last day of month previous to the one in which tenders are invited.

- (c) Any agency involved / engaged in litigation/ arbitration with the Department at present or blacklisted with any Govt. / Autonomous organization are discouraged and disqualified from participation in this tender. In the event of such disclosure at later stage even after acceptance/ award of work, shall automatically lead to termination of contract including forfeiture of earnest money including security deposit.
