The Executive Engineer, Chayangtajo Division, PWD, AP, Chayangtajo on behalf of the Governor of Arunachal invites sealed item rate tender in CPWD Form-8 in Single Bid system from the eligible registered firms/contractors domiciled within the territorial jurisdiction of Community Block as per the Arunachal Pradesh District based entrepreneurs and professionals (incentives, development and promotional at 2015 under which the work is to be executed for work as stated below:-

- The application should be submitted along with the following documents failing which no tender paper shall be issued.
- (i) Attested copy of valid registration /enlistment paper confirming the eligibility of the firm.
(ii) List of works equivalent amount as described in NIT of similar work executed during last 5 years. Certificate should be duly signed by the competent authority not below the rank of Executive Engineer of that organization.
 - Tender documents can be purchased from **the office of the Assistant Engineer, Chayangtajo Sub-Division, PWD, AP at Camp office Seppa** on payment of Cost of Tender Paper in cash (non-refundable) upto **1600 Hours** on **08/02/2019** by submitting application for issue of forms.
 - Tender paper shall be received upto to **1200 hours on 14/02/2019 at the office of the Executive Engineer, Chayangtajo PW Division, AP, Camp-Office Seppa** and shall be opened on the same day at **1300 hours** in presence of intending contractors or their authorized representatives.
 - The earnest money should be deposited to any of the scheduled Banks and receipt of Treasury Challan / Deposit at Call Receipt of scheduled bank / Fix Deposited Receipt of a scheduled bank / Demand Draft of a scheduled bank guaranteed by the Reserve Bank of India issued in favour of **the Executive Engineer, Chayangtajo Division, APPWD, payable at State Bank of India, Seppa Branch (Code:-5738)** should accompany the Tender Documents.
 - The Tender without earnest money shall be **summarily rejected**.
 - The undersigned **reserves the right to reject any or all the Tender** without assigning any reasons.
 - Tender paper shall be issued only on production of the necessary certificate in support of desired class of contractors.
 - Once tender paper issued in favour of particular name/Firm shall not be changed in any circumstances.
 - The estimated cost put to tender based on APSR-2018.
 - In the larger interest of the public and for equitable distribution of developmental works, a contractor shall be allowed to have only 3 (three) works in hand in any of developments under government of Arunachal Pradesh at a time and for which he shall make a declaration to be executed in an affidavit that he is not engaged in more than two any tenders work under the state government. He shall also for participation in any tender be required to submit completion certificate issued by the engineer-in-charge duly counter signed by the concerned Superintending Engineer and Chief Engineer.
 - The APST contractors shall submit ST certificate to avail relaxation of Earnest Money in favour of them. Original ST Certificate should be produced at the time of opening of the Tender. No relaxation shall be admissible without submission of St Certificate.
 - Payment shall be made as per availability of fund & LOC.
