The Executive Engineer, Ziro Division, PWD, AP, Ziro on behalf of the Governor of Arunachal Pradesh, invites Sealed Item rate Tender from APPW registered contractors in Class-IV & Class-III categories domiciled within the territorial jurisdiction of Assembly Constituency under which the work is to be executed for the work stated below :

- The participants must submit proof of possessing T&Ps as required under **SCHEDULE-"F"** of the tender document without which tender shall be rejected.
- The participants must submit proof of having technical personnel's with proof of qualification, experience, age, address etc. as required under **SCHEDULE - "F"** of the tender document without which the tender shall be rejected.
- Tender paper can be purchased from the **Assistant Engineer, Ziro Sub-Division, PWD, Ziro** on all working days by submitting Application along with requisite experience certificate and on payment of Cost of Tender Paper in cash (non-refundable) from **16/2/2016 to 18/2/2016** (up to **1600 hrs**). Tender Document requested by mail/post will be dispatched by registered/speed post on payment of an extra amount of **Rs. 1000.00**. The department will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
- Tender must be delivered to the **Executive Engineer, Ziro Division, PWD, AP, Ziro** on or before **1130 hrs on 22/2/2016**. The Tender will be opened on the same day i.e. **22/2/2016 at 1500 hrs** in the office of the Executive Engineer, Ziro Division, PWD, AP by him or his authorized representative in the presence of intending tenderers.
- The Earnest Money of the amount specified above in the form of Fixed Deposit Receipt/Term Deposit Receipt in favour of the Executive Engineer, PWD AP, Ziro should be enclosed with the Tender document in separate sealed cover.

The intending Firms/Contractors should furnish the No-Due Certificate (NDC)/ No Objection Certificate, (NOC) from Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issued on or after 30/09/2015 by the Managing Director Cum Chief Executive Officer, Naharlagun. No Tender Paper shall be issued to any intending bidder without submission of NDC from Arunachal Pradesh State Co-Operative Apex Bank Limited.
8. The intending Firms/Contractor should submit Income Tax clearance Certificate for the last one year or Income Tax exemption certificate as the case maybe.
9. Other document/information required to be furnished by the tenderers are described in the Tender documents.
10. Bidders are advised to inspect the site and its surroundings and satisfy themselves before submitting their tenders.
11. The competent authority reserved the right to reject any or all the Tender without assigning any reason
12. The Tender without earnest money in proper form shall be summarily rejected.
13. The Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development and Promotional) Act'2015 shall be applicable in this tender.
