Interested bidders may obtain further information at the same address. Bidding documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of ₹ 2000.00 (Rupees Two Thousand) only. The Executive Engineer, Yingkiong Division, PWD, AP, Yingkiong will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
- 3. Bids must be accompanied by security of the amount specified for the work in the table, payable at State Bank of India, Yingkiong Branch and drawn in favour of Executive Engineer, Yingkiong Division, PWD, AP, Yingkiong. Bid security will have to be in anyone of the forms as specified in the bidding document and shall have to be valid for 45 (Forty Five) days beyond the validity of the bid.
- 4. Bids under two separate sealed covers for individual packages super scribed as "TECHNICAL BID' and 'FINANCIAL BID' must be delivered to Executive Engineer, Yingkiong Division, PWD, AP, Yingkiong on or before 24.09.2016 hours on 1500 Hrs and will be opened on the same day at 1530 hours, in the presence of the bidders who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.

Technical Bids shall be evaluated by a screening/evaluation committee at the Division/Circle/Zonal level whose decision shall be final as the case may be, and the bidder(s) who quality shall be invited to attend the opening of "Financial Bids" for which date, time and venue will be intimated later on.

- 5. A pre-bid meeting will be held on **21.09.2016** at **1100** hours at the office of Superintending Engineer, Boleng Circle, PWD, Boleng, Arunachal Pradesh to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of 'Instructions to Bidders' of the bidding document.
- 6. The bidder who fulfills the following initial requirements shall only be eligible to participate
  - a) Experience of having successfully completed at least one similar work of aggregate cost not less than ₹ 1600.00 Lakh (Rupees Sixteen crores) only, during last 5(five) years ending last day of March'2016.
  - b) Has an annual financial turn over in civil engineering construction works in any one year during the last 5(five) years ending March'2016 of value not less than ₹ 2800.00 Lakh (Rupees Twenty eight crores) only.
- 7. Any contractor who has 2 (two) or more uncompleted ongoing commitment in any Works Department of Arunachal Pradesh (projects to execute/contracts at hand) is not permitted to participate in this tendering. A bidder will invariably submit an affidavit sworn before a competent Magistrate to the effect that he does not have 2 (two) or more uncompleted ongoing commitments at the time of bidding. The affidavit should mention the names of the uncompleted ongoing commitments. He shall also, for participation in any bid be required to submit completion certificate issued by the Engineer-in-charge duly counter signed by the concerned Superintending Engineer. Any bid which does not fulfill this condition will be summarily rejected. In the event of submission of false information, which may be detected by the department after award of work, the bid shall be cancelled immediately and the contractor shall be barred from further participation in any tender works of the department.
- 8. The bidder will have to submit **No Due Certificate** (NDC) / **No Objection Certificate** (NOC) from Arunachal Pradesh State cooperative Apex bank Limited, not older than 3(three) months, duly issued by the Managing Director cum Chief Executive Officer, Itanagar along with the tender.
- All the required information and documents should be submitted strictly in the formats given in the bid/tender document. Other standard formats may be adopted only in cases where no formats have been prescribed in the Tender document.
- 10. All affidavits, undertakings, agreements etc. should invariably be sworn before a magistrate and they should be specific.
- 11. No attested copies of documents that ought to be submitted in original shall be accepted.
- 12. The bidder, at the bidder's own responsibility and risk is encouraged to visit the project site and obtain necessary information related to it to facilitate preparation of the tender.
- 13. In the event of more than one qualified tenderer quoting the same amount, the award of work shall be determined by the Bid capacity of the bidder, inclusive of conditions of clause 4.8 of ITB
- 14. All the requisite information/documents mentioned in (6), (7), (8) and (9) above should be submitted in an orderly manner as and where required by indexing them as detailed in the relevant section(s) of the bidding document. The guarantees, certificates, etc from bank(s) and other authorities and other information shall be furnished as per the standard forms given in the relevant section(s) of the Bid Document. They must not be older than three (3) months and must be signed by competent authority himself/herself with proper official seal.

- 15. The Employer reserves the right to accept or reject any bid, and to cancel the bidding process and reject all bids, at any time prior to the award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform affected bidder or bidders of the grounds for the employer's action.
