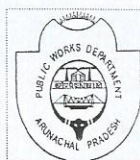


The tenders without Earnest Money shall be summararily rejected.
