In exercise of the power conferred by proviso to Article 309 of the constitution of India, the Governor of Arunachal Pradesh is pleased to amend the following Recruitment Rules for the post of Stenographer, Gr.II(Group 'C') in the Arunachal Pradesh Stenographer Service Government of Arunachal Pradesh issued vide notification No.Estt(A)-130/73 dated 12.3.92.

1. These rules may be called the Stenographer, Gr.II (Group 'C') Recruitment Rule amended 1994.
2. They shall come into force with effect from 26.2.1994
3. In column 10 of schedule I of the Recruitment Rules the following provision shall be substituted :
  - a) 66½% by promotion from amongst the Steno Gr.III who have rendered not less than 5(five) years continuous service in the Steno, Gr.III and have to qualify 100 WPM in Stenography.
  - b) 33½% by direct Recruitment (30% post reserved for APSI candidate) to be qualified in the following subject.
    - a) General English(Including Essay writing) - 100 marks
    - b) General knowledge - 100 marks
    - c) Speed test in Stenography-100 WPM - 100 marks

Gr.II and steno Gr.III Notified vide No. Estt(A)-130/73 dated 6th April/85 and notification dated 3rd Nov/1986.

Item No. 10(b) para-2. In the case of departmental candidates who possess educational qualification of P.U. or equivalent and above as prescribed for direct recruitment to steno Gr.II posts, the restriction of 5 years minimum service would not apply.

Departmental candidate who possess the aforesaid qualification can compete against direct recruitment upto the age limit of 40 years.
