Bidding/ tendering documents (and additional copies) may be purchased from the office of the Executive Engineer, Roing Division, PWD, AP, Roing from 5.12.2012 to 14.12.2012 for a non refundable fee as indicated, in the form of Cash or Demand Draft on any scheduled bank payable at **STATE BANK OF INDIA, ROING** in favour of the **EXECUTIVE ENGINEER, ROING DIVISION, PWD, AP, ROING**. Interested bidder (s) may obtain further information at the same address. Bidding document requested by mail will be dispatched by registered/speed post on payment of an extra amount Rs. 1000.00. The department will not be held responsible for the postal delays, if any, in the delivery of the documents or non-receipt of the same.
2. Bids must be accompanied by bid security/ earnest money of the amount specified for the work in the table, payable at State Bank of India, Roing, drawn in favour of **EXECUTIVE ENGINEER, ROING DIVISION, PWD, AP, ROING**. Bid security will be in cash (upto Rs.10000.00.)/- Receipt Treasury Challan / Deposit at Call Receipt of a schedule bank/ fixed deposit receipt of a scheduled bank/demand draft of a scheduled bank issued in favour of EE, PWD, Roing Division, A.P. 50% of earnest money or **Rs. 20.00** lakhs, whichever is less, will have to be deposited in the shape prescribed above and balance amount of earnest money can be accepted in the form of Bank guarantee issued by a scheduled bank having validity for 6 months or more from the last date of receipt of tender
3. Bids in complete shape must be delivered to the **EXECUTIVE ENGINEER, ROING DIVISION, PWD, AP, ROING**, on working days and latest by **1500 hrs** on or before 19.12.2012. The tender will be opened on the same day at 1530 hrs in the presence of bidder(s) who wish to attend or authorized representative of the bidder(s). If the office happens to be closed on the last date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. The tender shall be evaluated by a standing screening committee whose decision shall be final.
4. A pre-bid meeting will be held on 15.12.2012 at **1130 hrs** in the office of the Executive Engineer, Roing Division, PWD, AP, Roing to clarify the issues and to answer questions on any matter that may be raised at that stage as per in Clause 16.10 of the CPWD works Manual.

5. The bidder who fulfills the following initial requirements shall only be eligible to participate.
  - (a) Should have executed three similar works each of value not less than 40% of estimated cost or two similar work each of value not less than 50% of estimated cost or one similar work of value not less than 80% of estimated (rounded to nearest Rs. 10.00 Lacs) in last 5 years ending last day of the month previous to the one in which the tenders are invited.
  - (b) Should have had an annual financial turn over in civil engineering construction works in any one year during the last (3) years ending **March, 2012** of value atleast 50% of the estimated cost put to tender (Rs. 40.00 lakhs )
6. The bidder will have to produce no due certificate ( NDC)/ no objection certificate (NOC) from the Arunachal Pradesh State Co-operative Apex Bank Limited, duly issued by the Managing Director cum Chief Executive Officer, Itanagar in order to participate.
7. Other details and other documents to be submitted will be as described in the tender document.
8. The bidder, at the bidder's own responsibility and risk is encouraged to visit the project site and obtain necessary information related to it to facilitate preparation of the bid.
9. The information/documents mentioned in (5), (6) and (7) above should be submitted in an orderly manner as and where required by indexing them as detailed in the relevant section(s) of the bidding document. The guarantees, certificates, etc from bank(s) and other authorities and other information shall be furnished as per the standard forms given in the relevant section (s) of the bidding document.
10. The award of work is subject to sanction of the project. In case of any changes in the scope of work after sanction the same shall apply to the scope of contract agreement also.
