NOTIFICATION

Dated, Itanagar the ^{31/10 /} November'2008.

In exercise of powers conferred by the proviso to Article 309 of the constitution of India and in supersession of all recruitment rules notified prior to notification of this rules, except as respect things done or omitted to be done before such supersession, the Governor of Arunachal Pradesh is pleased to make the following rules to regulate the method of recruitment to the post(s) of Peon./Chowkidhar/Dak Runner/Mali/Sweeper/Follower/Kennel man/Water carrier Group "D" post(s) in all departments/offices under the Government of Arunachal Pradesh as in the schedule annexed namely:-

1 Short Title and commencement: - (i) These rules may be called Peon./Chowkidhar/Dak Runner/Mali/Sweeper/Follower/Kennel man/Water carrier, "Group "D" Recruitment Rules 2008.

(ii) They shall come into force on the date of their publication in the Gazette.

2 These rules shall apply to the post(s) as specified in column 1 of the schedule Annexed to the Rules.

3. Number of posts, classification and scale of pay: -The number of post(s), their classifications and the scale of pay attached thereto shall be as specified in column 2 to 4 in the schedule aforesaid.

4 Method of Recruitment, age limit and other qualifications:-

The method of recruitment to the posts, age limit, qualifications and other matters relating there to shall be as specified in columns 5 to 14 of the schedule aforesaid.

5 Disqualification: - No person.

a).who has entered into or contracted a marriage with a person having a spouse living or

b). who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for the appointment to the said post.

Provided that the Governor of Arunachal Pradesh may, if satisfied that such marriage is permissible under the personal Law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of these rule.

6 Power to relax :- where the Governor of Arunachal Pradesh is of opinion that it is necessary or expedient so to do, he may by order for reasons to be recorded in writing and in consultation with the Selection Board/ Arunachal Pradesh Public Service Commission relax any provisions of these rules with respect to any class or category or person.

7 Repeal and saving: - All rules and procedures corresponding to these rules and procedures in force immediately before the commencement of these rules are hereby repealed, provided that any order made or action taken under the rules so repealed shall be deemed to have been validity made or taken under the corresponding provisions of these rules.

Nothing in these rules shall effect reservation/ relaxation of age limit and other concessions required to provide for the Arunachal Pradesh Schedule Tribes and other special categories of persons in accordance with the orders issued by the Government of Arunachal Pradesh from time to time in this regard.



No.AR-85/2009::In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules further to amend the General Arunachal Pradesh Group 'D'(Non-Ministerial) Common Recruitment Rules,2009 in so far as they relate to the post of Peon/ Chowkidhar/Dak Runner/Sweeper/Kennel man/Water Carrier under the Government of Arunachal Pradesh, namely :-

1. Short title and commencement :- (1) These rules may be called the General Arunachal Pradesh Peon/ Chowkidhar/Dak Runner/Sweeper/Kennel man/Water Carrier Group-'C' (Non-Ministerial) Common Recruitment (Amendment) Rules,2009.

(2) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette

Amendment :- (i) in the aforesaid Rules and the Schedule annexed there to for the words "scale of pay" the words "Pay Band and Grade pay/Pay Scale" shall be substituted.

(ii) In the Schedule,--

(a) for the Entries Group "D" in column 3 the entries "Group -C" shall be substituted.

(b) for the Entries in column 4, the entries "Pay Band -Rs.5200-20,200/- Grade Pay Rs.1800"- shall be substituted.

(c) for the Entries Class -V column 8, the entries "matriculation/ITI/equivalent" shall be substituted.



No. AR-175/2010/II.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Arunachal Pradesh is pleased to make the following rules further to amend the General Arunachal Pradesh Group 'C' (Non-Ministerial) Common Recruitment Rules, 2008 in so far as they relate to the post of Peon/Chowkidar/Dak Runner/Sweeper/Kennel man/ Water Carrier under the Government of Arunachal Pradesh, namely:-

1. **Short title and commencement :** (1) These rules may be call the **General Arunachal Pradesh Peon/Chowkidar/Dak Runner/Sweeper/Kennel man/ Water Carrier Group 'C' (Non-Ministerial) Common Recruitment (Amendment) Rules, 2011.**

(2) They shall come into force on the date of their publication in the Arunachal Pradesh Gazette.

2. **Amendment :** In the Common Recruitment Rules to the post of Peon/Chowkidar/Dak Runner/Sweeper/ Kennel man/Water Carrier Notified vide No. AR-118/06 dated 5th November, 2008 and No. AR-85/09 dated 4th June, 2010 against column No. 11 the following shall be substituted namely :

"(a) 75% by direct recruitment. Recruitment shall be made on the basis of the merit adjudged on the following subjects :-

1. General English	—	100 Marks.
2. General Knowledge	—	100 Marks.
3. Elementary Mathematics	—	100 Marks.
4. Viva-voce	—	40 Marks.
Total	—	340 Marks

Note : Minimum marks shall be as per Office Memorandum No. OM-54/06 dated 7th January, 2008.

(b) 25% posts shall be appointed from the serving contingent staff who have put in a minimum of 20 years and more continuous service".

Note : Appointment of the 25% contingency posts shall be as per the provisions of the Office Memorandum No. AR-176/10 dated 15th February, 2011.
