**Sub: Pre-feasibility study of Trans-Arunachal Highway**

Sir,

It is to bring to your kind attention that the **Trans-Arunachal Highway**, a 2-laned National Highway standard trunk route, about 1811 KM in length running along the middle belt of Arunachal Pradesh from Tawang in the north western tip to Kanubari on the south western end of the State, forms a part of the development package announced by the **Prime Minister Shri Manmohan Singh** during his last visit to Itanagar on 31.01.2008.

2. The Chief Engineer (P-10), Ministry of Shipping, Road Transport & Highways, New Delhi vide his letter No. 12037/7/2008/Ar.P.NH-10 dated 04.02.2008 (copy enclosed) has asked the State PWD to submit pre-feasibility report of the proposed Trans-Arunachal Highway. Ministry expects the report to be submitted within the month of **June/2008**.

3. Necessary formalities are also underway for declaration of this route as **National Highway for taking up under SARDP Phase-‘A’**. Govt. of India proposes completion of the Trans-Arunachal Highway to 2-lane standards during 11th and 12th Five Year Plans including all other roads of the package namely District Headquarter connectivity, missing link between NH-37 and NH-52 and roads to facilitate all power sector projects as announced by the Prime Minister.


4. The major portion of roads in the State are owned by BRO. The required details sought by Ministry shall have to be furnished jointly by PWD and BRO. The PWD officers in the areas falling under your jurisdiction are being instructed to approach the officers under your sector to pick up the necessary details.

5. On 25.03.2008, **His Excellency the Governor** had taken a brief review of the follow up actions on PM’s Package. He would like to review the progress sometime in July/2008.

6. I would therefore like to request you kindly to extend all possible assistance to State PWD officers in furnishing necessary details without further loss of time.



**Subject:- Trans Arunachal Highway**

Sir,

A pre-feasibility report for improvement of roads along the alignment of proposed Trans Arunachal Highway may be got made through State PWD. The pre-feasibility report may essentially cover the following aspects:-

- (i) Route of the Highway showing important places;
- (ii) Details of the existing road: the land width, formation width, carriageway width, location of culverts and bridges with details;
- (iii) Locations of realignment along with the siting of bridges, estimated waterway of the bridges & culverts;
- (iv) Requirement of additional land;
- (v) Preliminary design of pavement/road/bridges;
- (vi) Locations of quarries for various construction materials;
- (vii) Approximate cost of improving the highway to 2-lane standards. Any special items, including the protection works, such as retaining wall, breast wall, etc. should be accounted for.

2. The above details maybe got prepared in convenient sections and sent to the Ministry early. The time frame for furnishing the information may be intimated to the Ministry.
