**OFFICE ORDER**

As per provision of Arunachal Pradesh Enlistment of Contractors in works department Rules, 2008 and subsequent amendments made from time to time the Superintending Engineer, Jairampur Circle, PWD, A.P. do hereby extend the validity of the following Contractors in Class-VA (Civil) Category for a period of 5 (five) Years from the date of expiry of last enlistment/revalidation order subject however to any further amendments in the Enlistment Rules made from time to time.

- 1 He will be eligible to tender for building and road works upto the list of Rs. 50.00 lakhs (Rupees Fifty lakhs) only within the jurisdiction of Jairampur PWD Circle, Arunachal Pradesh.
- 2 (a) He shall be required to deposit earnest money with each tender as per terms and conditions of the tender/agreement.
- (b) Security Deposit will be recovered from their bills in accordance with the rules in force from time to time. He will have to apply to the Income Tax Officer of the area in which they are assessed for grant of Income Tax License Clearance Certificate in the month of May every year. The Income Tax Clearance Certificate in original or a copy thereof duly attested by Gazetted Officer or a notary Public should be submitted to this office by the end of June every year. If they fail to send copies of Income Tax License Clearance Certificate, their name will be liable to be removed from approved list of contractor ( For General Category only).
- 3 He will have to abide by the terms and conditions of the contract as they stand or as may be altered from time to time.
- 4 He shall not enter into any fresh or modify the existing partnership without prior approval of enlistment authority. In case, He wish to enter into any partnership, they must intimate in advance giving full details of the partnership deed. Any deviation from this, the contractor is liable to be removed from the approved list of contractors of the Department.
- 5 He shall not be permitted to tender for works in the Circle responsible for award and execution of contract in which their near relatives is posted as Divisional Accountant or as officer between the grades of SE and JE (Both including).
- 6 He shall also intimate to this office the names of persons who are working with them in any capacity or subsequently employed by them and who are near relatives of any gazetted officer in AP, PWD. Any breach of the condition by the contractor shall render them liable to be removed from the approved list of contractors in the Department.
- 7 They are requested to secure works of required magnitude in the Department. In case, they fail to secure any work of the required magnitude during the period of 5 (five) consecutive years, the enlistment of the contractor is liable to be weeded out from the approved list of contractors of this department.

- 8 The enlistment notified in this order is valid for a period of 5 (Five) years from the date of issue of this order. The contractor will be required to apply for revalidation of their enlistment \*6 (six) months before the expiry of their enlistment. In case where the application is received within 3 month after date of expiry of enlistment/revalidation. The application can be accepted with double the revalidation processing fee & application received there after shall not be accepted & contractor should apply for fresh enlistment as per rules.
- 9 He shall be bound by the enlistment rules of the Department as amended from time to time.
- 10 He will also intimate the change in their permanent address if any, further in case they fails to intimate such change to the department their names would be removed from the approved list of contractor.
