OFFICE ORDER

As per "Enlistment Rules 2008 & 2018" for contractor enlistment and re-validation, the enlistment of M/s Khamhoo Enterprises, Prop. Chow Cheyapingya Khamhoo, Vill. Nampoong, PO, PS & District-Namsai, A.P. under the 47(ST) Namsai Assembly Constituency enlisted vide No.SETC/Cont-33/2008-09/V-A/60 dtd. 29/12/2008 in Class-V - A (Civil) category is hereby re-validated and extended for a period of another 5(five) years w.e.f. 29/12/2019.

Terms & Conditions:-

1. The enlisted contractor(s) will be eligible to tender for Building and Road works upto the limit of Rs.50.00 lakhs (Rupees fifty lakhs) only in the jurisdiction of 47(ST) Namsai Assembly Constituency. All terms and condition shall be as per Govt.of A.P. notification vide No.SPWD/W-336/Contract/2006-07/1079 dtd. 1st October, 2018 of Arunachal Pradesh District Based Entrepreneurs and Professionals Act 2015.
2. Contractor(s) shall be required to deposit earnest money with each tender as per terms and conditions of the tender / agreement.
3. Security deposit will be recovered from the contractor bills in accordance with the rules in force from time to time.
4. Contractor(s) shall employ the required technical staff in accordance with these Rules and as per terms and conditions of each NIT / Contract / Agreement.
5. Contractor(s) shall be in possession of T&P and equipment as laid down in these Rules and as per each NIT / Contract / Agreement.
6. Contractor(s) shall not enter into any fresh, or modify the existing, partnership without prior approval of the department. In case, contractor(s) wish to enter into any new, or modify of existing partnership, contractor(s) must intimate in advance with full details of the partnership deed. Any departure from this will render the contractors liable to be removed from the approved list of contractors of the department.
7. Contractor(s) shall not be permitted to tender for works in the Circle of the department responsible for award and execution of contract in which his/her near relative(s) is / are posted as Divisional Accountant or as an officer between the grades of SE and JE (both inclusive). They should also intimate to this office the names of persons who are working with them in any capacity or are subsequently employed by them, who are near relatives of any Gazetted Officer in the department. Any breach of this condition by the contractors shall render them liable to be removed from the approved list of contractor.
8. The revalidation notified in this order is valid for a period of 5(five) years from 06/02/2019. The contractor shall have to apply for further revalidation of their enlistment 6(Six) months before the expiry of the revalidation. In case of the application of contractor for further revalidation is received after the date of expiry of the revalidation, his/her enlistment is liable to be cancelled.



9. Contractor(s) shall also intimate the change, if any, in the address of his/her Registered Office / Head office. In case he/she fail to intimate such change to the department, his/her name would be liable to be removed from the approved list of contractors.
10. Contractor(s) are required to secure works of required magnitude in the works departments under State Government. In case, they fail to secure any work of the required magnitude during the period of 5(five) consecutive years the enlistment of the contractor is liable to be weeded out from the approved list of contractors of the department.
11. The enlisted contractors shall be required to completed the form of Annual Confidential Report of contractor in duplicate in the manner as prescribed in these Rules.
12. Contractor(s) should not indulge in unethical practices and shall maintain good conduct.
13. They shall abide by the Enlistment Rules of the department as amended from time to time and terms and conditions of NIT / Contract / Agreement. They shall execute works as per stipulated time and specifications. For omissions and commissions as laid down in these Rules they may be demoted to a lower class, their business with the department suspended for any period, or their names be removed from the approved list. The decision of the enlisting authority in this regard will be final.


