1. The Executive Engineer, Mariyang Division, PWD, Mariyang, AP, invites bids on behalf of the Governor of Arunachal Pradesh for execution of the work on **Turnkey basis** as detailed below:

Interested bidders may obtain further information at the same address. Bidding Documents requested by mail will be dispatched by registered/speed post on payment of an extra amount of Rs. 1000/-. The department will not be held responsible for the postal delays, if any, in the delivery of the documents or non-receipt of the same.
2. Bids must be accompanied by Bid Security for the amount specified in the Table above, in the form of receipted Treasury Challans/ Deposit at Call Receipt of a scheduled Indian bank / Fixed Deposit of a scheduled Indian bank/ Bank Guarantee, issued in favour of the

**Executive Engineer, Mariyang Division, PWD, Mariyang.** The validity of the Bid Security shall be as per the bidding document.

3. Bids under two separate sealed covers for the work superscribed as **“Technical Bid”** and **“Financial Bid”** must be delivered to the **Executive Engineer, Mariyang Division, PWD, Mariyang** on working days and latest by **1500 hours on 09-09-2010**. The **“Technical Bids”** will be opened on the same date at **1530 hours** in the presence of intending bidder(s) or their authorized representatives who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. **“Technical Bids”** shall be evaluated by a screening committee whose decision shall be final and the bidder(s) who qualify shall be invited to attend the opening of the **“Financial Bids”** for which date and venue will be intimated later on.  
It may also be ensured that the **“Technical Bid”** and the **“Financial Bid”** shall be **hard bound with pages serially numbered, provided with an index page** and sealed separately and submitted under a common cover. Hard bound implies such binding between two covers through stitching or otherwise whereby it may not be possible to replace any paper without disturbing the document. **The bids not submitted in hard bound condition shall be summarily rejected.**
4. A Pre-Bid Meeting will be held on **28-08-2010 at 10.30 hours** in the office of the **Superintending Engineer, Boleng Circle, PWD, Boleng** to clarify the issues and to answer questions on any matter that may be raised at that stage. However, as per clause 9 of **“Instruction to Bidders”**, the bidder is requested to submit questions beforehand so as to reach the office of the **Superintending Engineer, Boleng Circle, PWD, Boleng** by **25-08-2010**.
5. The bidder who fulfills the following initial requirements shall only be eligible to participate:
  - a) Experience of having successfully completed one similar work of aggregate cost not less than Rs. 235 lakhs during the last five (5) years ending last day of June/ 2010.
  - b) Should have had an annual financial turnover in civil engineering construction works in any one year during the last five (5) years ending March 2010 of Rs. 665.00 Lakhs.
6. The bidder will have to produce **“No due” certificate (NDC)/no objection certificate (NOC)** from the Arunachal Pradesh State Cooperative Apex Bank Limited, duly signed by the Managing Director/ Chief Executive Officer, Apex Bank, Itanagar in order to participate.
7. Other details and other documents to be submitted will be as described in the bidding document.




8. The bidder, at the bidder's own responsibility and risk is encouraged to visit the project site and obtain necessary information related to it to facilitate preparation of the bid.
