Bids must be accompanied by bid security of the amount specified for the work in the table, in the form of receipted treasury Challans/Deposit at Call receipt of a schedule bank/ fixed deposit of a schedule bank/bank guarantee issued in favour of Executive Engineer, PWD, Kanubari, Arunachal Pradesh.
3. Bids under two separate sealed covers for individual packages super scribed as “**Technical Bid**” and “**Financial Bid**” must be delivered to the Executive Engineer, Kanubari PW Division on working days and latest by 1500 hrs on or before **08/03/2013** The Technical Bid will be opened on the the same day at 1530 hrs in the presence of bidder(s) who wish to attend or authorized representative of the bidder(s). If the office happens to be closed on the last date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. “**Technical Bids**” shall be evaluated by a standing screening committee whose decision shall be final and the bidder(s) who qualify shall be invited to attend the opening of “**Financial Bids**” for which the date and venue will be intimated later on.
4. A pre-bid meeting will be held on **05/03/2013** from 1100 hrs to 1300 hrs in the office of Executive Engineer, PWD, Kanubari, A.P to clarify the issues and to answer questions on any matter that may be raised at that stage as stated in Clause 9.2 of '**Instructions to Bidders**' of the bidding document.
5. The bidder who fulfills the following initial requirements shall only be eligible to participate.
  - (a) Experience of having successfully completed one similar work of aggregate cost not less than Rs. 150.00 Lakhs during the last 5 years ending last March 2012.
  - (b) Should have had an annual financial turn over in Civil Engineering construction works in

any one year during the last five (5) years ending March, 2012 of Value Rs. 300.00 Lakhs.

6. The bidder will have to produce no due certificate (NDC) / No Objection Certificate (NOC) from the Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issue by Managing Director Cum Chief Executive Officer, Itanagar.
7. Other details and other documents to be submitted will be described in the bidding document.
8. The bidder, at the bidder's own responsibility and risk is encouraged to visit the project site and obtain necessary information related to it to facilitate preparation of the bid.
