
NOTICE INVITING TENDER

1. Division.
2. Bids must be accompanied by bid security of the amount specified for the work in the table, payable at State Bank of India, Chowkham, drawn in favour of Executive Engineer, Namsai P.W. Division. Bid security will have to be in any one of the forms as specified in the bidding documents and shall have to be valid for 45 days beyond the validity of the bid. The earnest money should be deposited alongwith the tenders in the appropriate form as given in CPWD 6 attached with the tender documents.
3. The tender will be opened at 1500 hrs. on the same day by the Executive Engineer, Namsai P.W. Division or by his authorized representative in presence of intending tenderer. The Executive Engineer or his authorized representative reserve the right to accept or reject any tender without assigning any reason.
4. The bidder who fulfills the following initial requirements shall only be eligible to participate.
 - i) Three similar works, each of value not less than 40% of the estimated cost put to tender or
 - ii) Two similar works, each of value not less than 60% of the estimated cost put to tender or
 - iii) One similar works of value not less that 80% of the estimated cost, all amount rounded off to a convenient full figure, in last 7 years ending on the last day of the month March'2012.
 - iv) Should have had an annual financial turn over in civil engineering construction works in any one year during the last 7 years ending March'2012 of value ₹ 30.00 lakhs.
5. Other details and other documents to be submitted will be as described in the bidding document.
6. The bidder, at the bidder's own responsibility and risk is encouraged to visit the project site and obtain necessary information related to it to facilitate preparation of the bid.

7. The information/ documents mentioned in (4) and (5) above should be submitted in an orderly manner as and where required by indexing them as detailed in the relevant section(s) of the bidding document.
