NOTICE INVITING TENDER

The Executive Engineer, Ziro Division, PWD, AP, Ziro on behalf of The Governor of Arunachal Pradesh invites Single Bid Two Envelope Sealed item rate Tender in CPWD form-8 from eligible registered contractors as per Arunachal Pradesh District based Entrepreneurs and professionals (incentives, development and promotional) Act 2015 and subsequent ammendment published vide notification published in Arunachal Pradesh extra ordinary Gazette vide no. 247Vol-XXVII dated 2nd November 2020 for following work(s).

1. Eligibility Criteria:

- (i) The eligibility of contractor/bidders shall be governed by the provisions of Memo No. SPWD/W-66/2012/314, dated 13/08/2015.
 - (ii) The participants must have successfully executive in centre/State Govt./PSU's three similar works each of value 40% of the estimate cost or two works each of 60% of the estimate cost or similar work of value 80% of the estimate cost during last five years.
2. Tender papers will be issued to eligible contractors on production of definite proof from the appropriate authority.
 3. The tenderer shall be submitted an affidavit in original from District Magistrate for having not more than two works in hand in any Department.
 4. Tender paper can be purchased from the **Executive Engineer, Ziro PWD Division, A.P Ziro** on all working days by submitting Application along with requisite experience certificate and on payment of Cost of Tender Paper in Demand Draft/ Bankers Check (non-refundable) from **17/03/2025 to 19/03/2025 (up to 1600 hrs)**. Tender Document requested by mail/post will be dispatched by registered/speed post on payment of an extra amount of **Rs.2,500.00** The department will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same.
 5. Tender must be delivered to the **Executive Engineer, Ziro Division, PWD, AP, Ziro** on or before **1130 hrs on 25/03/2025**. The Tender will be opened on the same day i.e. **25/03/2025 at 1500 hrs** in the office of the Executive Engineer, Ziro Division, PWD, AP by him or his authorized representative in the presence of intending tenderers.
 6. The Earnest Money of the amount specified above in the form of Deposit at call Receipt/Fixed Deposit Receipt/Term Deposit Receipt in favour of the Executive Engineer, PWD AP, Ziro should be enclosed with the Tender document in separate sealed cover.
 7. The intending Firms/Contractors should furnish the No-Due Certificate (NDC)/ No Objection Certificate (NOC) from Arunachal Pradesh State Co-Operative Apex Bank Limited, duly issued on or after **31/10/2024** by the Managing Director Cum Chief Executive Officer, Naharlagun. No Tender Paper shall be issued to any intending bidder without submission of NDC from Arunachal Pradesh State Co-Operative Apex Bank Limited.

8. The intending Firms/Contractor should submit Income Tax clearance Certificate for the last one year or Income Tax exemption certificate as the case maybe.
9. Other document/information required to be furnished by the tenderers are described in the Tender documents.
10. Bidders are advised to inspect the site and its surroundings and satisfy themselves before submitting their tenders.
11. The competent authority reserved the right to reject any or all the Tender without assigning any reason.
12. The payment shall be made as per allocation of fund according to year wise phasing. The department shall not be held responsible for delay in payment in case of non-released of fund by the Govt. as per phasing.
13. The Tender without earnest money in proper form shall be summarily rejected.
14. The APST contractors shall submit ST Certificate to avail relaxation of Earnest Money in favour of them. Original ST Certificate should be produced at the time of opening of the Tender. No relaxation shall be admissible without submission of ST Certificate.
