The Executive Engineer, Capital Division-A, PWD, Arunachal Pradesh, Itanagar on behalf of the Governor of Arunachal Pradesh invites online item rate e-tender in **single bid system** from all registered contractors in **class-II & class-III** categories **domiciled within the territorial jurisdiction of the Assembly Constituency** and shall be governed by the provision defined under Arunachal Pradesh District Based Entrepreneurs and Professionals (Incentives, Development & Promotional) Act 2015 with up-to-date Amendment Act, 2020 notified in Arunachal Pradesh Extra-Ordinary Gazette vide No. 247, Vol-XXVII, dated 2nd November 2020 for following work:

2. The bidding documents downloaded from the website should not be tampered and if any such tampering is noticed before and after the opening of the bids, the bidders shall be penalized and blacklisted.

CPWD-6, Proforma of Schedules A to F, Special conditions/Specifications and Drawings only will be uploaded to tendering website. The GCC-2020 (standard form) will be uploaded along with the Tender documents and the same shall form part of the agreement to be drawn and signed by both parties after acceptance of tender.

Criteria of eligibility for APPWD as well as Non-APPWD contractors.

1. In the larger interest of the public and for equitable distribution of development works amongst eligible contractors and also to ensure effective management and quality of works, a contractor shall be allowed to have only 2 (Two) works in hand in any of departments under Government of Arunachal Pradesh at a time and for which he shall make a declaration to be executed in an Affidavit that he is not engaged in more than two tenders works under the State Government of Arunachal Pradesh.
2. 3 (three) similar works each of value not less than ₹ 118.19 Lakhs (40% of estimated cost) or 2 (two) similar works each value not less than ₹ 177.29 Lakhs (60% of estimated cost) or 1(one) work of value not less than ₹ 236.38 Lakhs (80% of estimated cost) [all figures rounded to nearest convenient figure], in the last 5 (Five) years ending last day of the month previous to the one in which the tenders are invited.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of receipt of applications for tender.

- 3 The original EMD should be deposited in the office of the Assistant Engineer Capital Sub-Division No.3/A, PWD, AP, Itanagar within the period of bid submission including Cost of Tender Paper ₹ 1000/- (Rupees One thousand) only in Cash and the receipt of the Same is Uploaded.

For the purpose of this clause 'similar work' means the works of " C/o RCC Protection Wall & RCC Drain etc" works in hilly/Plain terrain with same nature".
