(The copy of receipt of Bid Fee issued by the Executive Engineer shall be scanned and uploaded to the e-tendering website by the intending bidders within the specified bid submission date and time, failing which the bid is liable to be rejected).





The details of the cost of documents and the Bid Security specified in the tender document should be same as submitted online (Scanned copies), otherwise will be summarily rejected. 4. Initial Criteria of eligibility for submission of bid documents for **APPWD** as well as Non-**APPWD** contractors:

- (a) The Bidder should have satisfactorily completed 03 (three) similar works each of value not less than 40% of estimated cost put to tender or 02 (two) similar works each value not less than 60% of estimated cost put to tender or 01(one) work of value not less than 80% of estimated cost put to tender during the last 07 (seven) years ending previous day of last day of submission of bids.

For the purpose of this clause 'similar work' means the works of "Construction of Civil Works".
