- Eligibility Criteria: The participants must have successfully executed three similar works each of value 40% of the estimated cost or two similar works each of value 60% of the estimated cost or one similar work of value 80% in Central/State Govt. organizations/PSU's during last five years.

- The Earnest Money Deposit (EMD) from APST contractors shall be accepted as per Government Order No. SPWD/W-182/2013 (pt)/ dated 06/07/2015 on production/ submission of valid document in original as proof of his/her being as APST Contractor.
