The Executive Engineer, Naharlagun Division, PWD, Arunachal Pradesh, Naharlagun invites on behalf of Governor of Arunachal Pradesh online item rate tender in CPWD form-8 in single bid (Technical & Financial) from all Class I registered contractors in AP PWD and equivalent class & categories registered with other enlistment authority and shall be governed by the provision defined under Arunachal Pradesh District based entrepreneurs and professionals (incentives, Development & promotional)(Amendment) Act 2020 ( Act No 7 of 2020) Schedule 7 under Section 3(1) and notified vide No. PWD-12/45/2021-Work-PWD/1133 dated 11.11.2021 for following work: -

2. The bidding documents downloaded from the website should not be tampered and if any such tampering is noticed before and after the opening of the bids, the bidders shall be penalized and blacklisted.
3. The bid can be submitted in electronic format in the website <https://arunachaltenders.gov.in>. within the specified time by paying Bid Fee ( non-refundable) in form of demand draft of Rs. 2000/- ( Rupees Two Thousand) only drawn in favour of Executive Engineer, Naharlagun Division, PWD AP, Naharlagun payable at SBI, Naharlagun Branch Code- 3232 for the work listed in the tender. ( The copy of Bid Fee

document and receipt of bid fee shall also be scanned and uploaded to the e-tendering website by the intending bidders within the specified bid submission date and time.

Before, submission of online bids, the bidders must ensure that the scanned copy of all the necessary documents have been attached with the Bids. The details of the cost of documents and the bid security specified in the tender documents should be same as submitted online.( scanned copy), otherwise will be summarily rejected. The department does not take any responsibility for delay caused due to non-availability or slow internet connection or network, traffic jam etc for online bids.


4. Initial criteria of eligibility for submission of bid documents for APPWD as well as Non-APPWD contractors:

5. The Bidder should have satisfactorily completed 3(Three) similar works each of value not less than Rs. 1113.52 Lakhs (40% of estimated cost put to tender) or 2(two) similar work each of value not less than Rs. 1670.29 Lakhs (60% of estimated cost put to tender) or 1(one) similar work of value not less than Rs. 2227.05 Lakhs (80% of estimated cost put to tender) during the last 7 (seven) years ending last day of month previous to the one in which tenders are invited.

For the purpose of this clause "similar work" means the works of "Construction of RCC Multi storey Building (G+1 & above)". The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last day of month previous to the one in which tenders are invited.

6. Any agency involved/ engaged in litigation/arbitration with the Department at present or blacklisted with any Govt./ Autonomous organization are discouraged and disqualified from participation in this tender. In the event of such disclosure at later stage even after acceptance/ award of work shall automatically lead to termination of contract including forfeiture of earnest money including security deposit.
