OFFICE ORDER

SUBJECT:- CANCELLATION OF ENLISTMENT OF CONTRACTOR

Whereas, M/s O G Enterprise, Rumgong, AP was enlisted as Class-I (B&R) Civil Category Contractor vide enlistment No. CEAP(CSQ)/W-48/2019-20/I/165 issued vide No. CEAP(CSQ)/W-48/I/165/2018-19/4182-89 dated 11.02.2019 on recommendation of Enlistment Board in its meeting held on 08.02.2019. The recommendation of the enlistment Board was on the basis of **client's certificate regarding performance of contractor** issued by the Executive Engineer, PWD, Pasighat Division, Arunachal Pradesh and countersigned by the Superintending Engineer, Boleng Circle, PWD, Boleng for the following works:

1. **Upgradation of Pasighat-Ledum-Tene-Koyu Road (0.00-20.00 km and reported to have completed during 2016-17.**
2. **Re-alignment of Pasighat-Pangin Road (2.00-19.75) and reported to have completed during 2015-16.**

Whereas, a complaint was received from one Shri Tadam Baja and party in this office on 09.08.2021 and subsequently a reminder complaint was received on 30/08/2021. The complainant had submitted the copies of the following letters obtained through RTI from the PIO cum Executive Engineer, Pasighat Division, PWD, Arunachal Pradesh, Pasighat in connection with aforementioned work:

1. **No. PA/RTI/2021-22/3032-36 dated 06/10/2021 stating that the work "Upgradation of Pasighat - Ledum - Tene - Koyu road (0.00 to 20.00 Km)" was not executed during 2014-15.**
2. **No. PA / RTI / 2021 - 22 / 2340 - 44 dated 12/08/2021 stating that the work " Re - alignment of Pasighat - Pangin Road (2.00 - 19.75 Km) was handed over to Highway Division, Pasighat, PWD, Arunachal Pradesh, Pasighat during 2011-12.**

Whereas, in view of information furnished by the PIO cum Executive Engineer, Pasighat Division, PWD, Pasighat and submitted to this office, it is evident that M/s OG Enterprise had submitted false document for obtaining registration as Class I (B&R) Civil Category Contractor vide No. CEAP (CSQ) / W - 48 / 2018 - 19 / 165.

Whereas, a letter was issued to M/s OG Enterprise seeking clarification on allegation labelled against them vide No. CEAP (CSQ) / W - 48 / I / 165 / 2021 - 22 / 325 dated 09/09/2021 and the reply furnished by M/s OG Enterprise is found not satisfactory.

Whereas, consequent upon unsatisfactory reply from M/s OG Enterprise, a show cause notice as to why their registration shall not be cancelled was issued vide this office letter No. CEAP (CSQ) / W - 48 / I / 165 / 2021 - 22 / 367 dated 30/09/2021 to M/s OG Enterprise under Clause - 24 (3) (e) & (f) of the Enlistment Rules - 2008 directing them to submit their reply within 7 (seven) days from the date of issue of the show cause notice.

Whereas, the reply to show cause notice from M/s O G Enterprise was received vide No. Nil Dated 06.10.2021 without satisfactory supporting documents.

Therefore, the Enlistment bearing No. **CEAP(CSQ)/W-48/2019-20/I/165** issued vide No. **CEAP(CSQ)/W-48/I/165/2018-19/4182-89** dated 11.02.2019 in favour of M/s **O G Enterprise**, Prop: Shri Obang Gao, S/o Shri Tapon Gao, Village: Jomo, PO/PS: Rumgong, District: Siang, Arunachal Pradesh, Pin: 791 001 is hereby cancelled and removed from approved list of contractors under Clause 24(3) of the Enlistment Rules-2008.


