It is for general information to all concerned that to ensure total transparency in award of Contract works/Purchase/Consultancy contracts in PWD, Arunachal Pradesh, all NIT/Bid documents shall be posted in its departmental website i.e. [www.arunachalpwd.org](http://www.arunachalpwd.org) irrespective of any tender value.

It is also further informed to all citizens that, the Central Vigilance Commission has conveyed the recent judgement of the Supreme Court of India in which the Apex Court has upheld that the award of contract on **Nomination Basis** or **Work Order** would amount to breach of **Article 14 of the Constitution** of guaranteeing right to equality, which implies right to equality to all interested parties. The Commission further directs that all **Nomination/Single Tender should also be posted on the website ex post-facto**. Thus, execution of major work through WORK ORDER/NOMINATION BASIS will be treated irregular carrying malafide intention. Full text of the judgement is available on the website.

The department is also taking sufficient measures for pro-active dissemination of information to citizens by posting various Govt. circulars, Guidelines, Work details being undertaken by PWD, Arunachal Pradesh.
