**NOTIFICATION**


1. As approved by the Cabinet Vice No. CAB/M-09/2006 dated 30/05/2006 the Forest Department Pool Qtrs. Have excluded from the purview of General Pool Qtrs.
2. In addition, the allotment of Qtrs. have been Decentralized and all the Sub-Pool Qtrs. maintained earlier by department have been returned to them for allotment and maintenance.
3. This Notification will not however, alter or modify the Qtrs. already allotted by the Urban Development and Housing Department prior to issue of this Notification on existing status and principle 'AS IS WHERE IS BASIS' status quo-ante.
4. Henceforth, the UD & Housing Deptt. will only allot accommodation under General Pool totaling 3502 Qtrs. /accommodation available in the State Capital Region. Consequent upon this De-centralization, other departments can only allot their respective pool Qtrs. When, its status is found vacant.
5. The officials entitled for Qtrs. Of other department other than General Pool Category will apply for accommodation to their Head of Officers and not the Department of UD & Housing.
6. This Notification will come into force with immediate effect.
