**OFFICE MEMORANDUM**

*Sub: Payment of Dearness Allowance and Dearness Relief to the State Government Employees and Pensioners/Family Pensioners respectively – Revised rates w.e.f. 01.07.2007.*

*In continuation of Finance Department's OM No. FIN/E-II/07/97 dated 01.11.2007 on the subject mentioned above, the Government of A is pleased to decide that the Dearness Allowance Relief payable to the State Government employees and pensioners/family pensioners respectively shall be enhanced from the existing rate of 35% to 41% with effect from 01.07.2007.*

*2. The additional installment of DA payable under this order shall be paid in cash to all the Govt. employees.*

*3. The expenditure on account of this additional Dearness Allowance will be met from existing Budget provisions of the Department concerned in the current finance year 2007-08.*


*4. The revised rates of Dearness Allowance will be applicable to regular State Govt. Employees and will not apply to private/non-Governmental institutions receiving grants-in-aids from the State Government.*
